Be it enacted by the Legislature of the State of Minnesota:

Commissioners appointed to locate state road. SECTION 1. That J. W. Bass, of the county of Ramsey, and David Edwards and Winthrop Young, of the county of Hennepin, be and are hereby appointed commissioners to locate, survey and establish a state road from the city of St. Paul, in the county of Ramsey, via Lake Como to Bay Street, in the city of St. Anthony, in the county of Hennepin.

When and where to meet.

SEC. 2. The said commissioners or a majority of them, shall meet at such place as may be most convenient, on any day subsequent to the passage of this act, and before the first day of January next, and proceed to the discharge of the duties imposed upon them by this act, and in the discharge of said duties may employ a competent surveyor and such chainmen and axmen as may be necessary.

SEC. 3. The said commissioners shall file a certified commissioners to plat of the survey of said road in the office of the county auditors of each of said counties, which plat shall be legal evidence of the location and existence of said road.

SEC. 4. All damages sustained by the laying out and Damages, how opening said road, shall be ascertained and determined by said commissioners or a majority of them, and shall be paid by the county in which such damages occur.

The board of county commissioners of Hennepin county, are hereby authorized and empowered to ap- To appropriate propriate money belonging to said county to such an money-for what amount as they may deem advisable, not however exceed- amount. ing the sum of three thousand dollars, to aid in the building and bridging of that part of said proposed road lying within the limits of Hennepin county.
