## CHAPTER LXXIX.

*An Act relating to the disposition of funds received for licenses by the City of Wabasha, State of Minnesota.*

Feb'y 24, 1870.

SECTION 1. Repeal of former Section.

2. Disposition of funds received by Board of Education for licenses,
3. When act to take effect.

*Be it enacted by the Legislature of the State of Minnesota:*

SECTION 1. That section three of chapter seventeen of the special laws of the state of Minnesota, approved March second, A. D. one thousand eight hundred and sixty-five, as amended by section numbered three, chapter thirty-three, of the special laws of the state of Minnesota, approved March seventh, A. D. one thousand eight hundred and sixty-seven, relating to the disposition of funds received for licenses granted by the city of Wabasha, and state of Minnesota, be and the same is hereby repealed.

Repeal of former section.

SEC. 2. That it shall be lawful for the board of education of the city of Wabasha, and state of Minnesota, to pay

into the treasury of said city any and all funds now in their possession that have been received by said board of education for licenses granted in and by said city of Wabasha.

## CHAPTER LXXX.

### *An Act for the relief of School District Number Sixty-four of Wabasha County.*

March 3, 1870.

SECTION 1. Clerk of school district to take an enumeration of children in said district—for what purpose.

2. When act to take effect.

*Be it enacted by the Legislature of the State of Minnesota :*

SECTION 1. That the clerk of school district number sixty-four, of Wabasha county, be permitted within twenty days after the passage of this act, to file in the office of the county auditor of Wabasha county, an enumeration of all persons between the ages of five and twenty-one years in said school district, and upon the filing of such enumeration, it shall be the duty of such county auditor to apportion to such school district number sixty-four, any money which it would have been entitled to by any apportionment of school money for the years eighteen hundred and sixty-nine and eighteen hundred and seventy, had it complied with all the provisions of the law relating to school districts.

SEC. 2. This act shall be in force from and after its passage.
