An Act to authorize the Board of Education of the City Peby 28, 1870. of Hastings to issue Bonds for school purposes.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That the board of education of the city of To lama bonds-Hastings are hereby authorized and empowered to issue in what amount. the bonds of the city of Hastings to an amount not exceeding five thousand dollars, with interest coupons attached, and pledge the faith of the city for the payment of the principal and interest at the time or times in said bonds or coupons named.

SEC. 2. All bonds issued by virtue of this act, shall what to be debe denominated the school bonds of the city of Hastings; of interest - when shall be signed by the president of the board of education, payable. attested by the clerk of said board, and sealed with the corporate seal of said city; shall bear interest at such rate as shall be fixed by said board, not exceeding twelve per cent. per annum, and shall be made payable at such time or times as said board of education may prescribe, not exceeding ten years from the date thereof.

SEC. 3. That said board of education are hereby authorized and empowered to negotiate and raise money on who to negotiate said bonds at not less than their par value, and said board purpose issued. are further authorized and empowered to use the money amount limited, raised from said bonds in payment of the indebtedness of said board of education. Provided, That the amount of school bonds of said city shall at no time exceed the sum of twenty thousand dollars.

An Act to amend Section Eleven, of Chapter Thirty, of the Special Laws of one thousand eight hundred and sixty-five, entitled an act to organize a Board of Education for the City of Owatonna, approved February twenty-fifth, one thousand eight hundred and sixty-five.

SECTION 1 Amendment to Section Eleven (11) of Obspier Thirty (30), Special Laws of 1865. Who may be appointed Superintendent of Schools-applicants for teachers' certificates by whom examined.

2. When act to take effect.

Be it enacted by the Legislature of the State of Minnesola:

SECTION 1. Section eleven, chapter thirty, of the special laws of one thousand eight hundred and sixty-five, entitled an act to organize a board of education for the city of Owatonna, approved February twenty-fifth, one thousand eight hundred and sixty-five, is hereby amended so as to read as follows:

Sec. 11. The board of education may appoint the principal of the schools the superintendent of the same, and fix his compensation. The superintendent and a committee of the board, or the superintendent when authorized by a vote of the board, shall publicly examine all persons offering themselves as teachers in said schools, and perform such other duties as the board may prescribe. SEC. 2. This act shall take effect from its approval.
