## CHAPTER XXVII.

An Act to amend an act entitled "An act to incorporate the Village of Caledonia," approved February twentyfourth, one thousand cight hundred and seventy.

## Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That section three of an act entitled an act to incorporate the village of Caledonia, approved February twenty-fourth, one thousand eight hundred and seventy, be amended so as to read as follows:

Sec. 3. The government of said corporation and the management of all its municipal concerns shall be vested in three trustees, one of whom shall be selected by themselves as president, one treasurer, one justice of the peace, one assessor, one constable, one clerk, who shall be residents ed-term of once of said village. The trustees, treasurer, justice of the peace, assessor, constable and clerk shall be elected by the qualified voters of said village. The trustees, treasurer, assessor, constable and clerk shall hold their office for one year, and the justice of the peace for two years, and until their successors are elected and qualified. The trustees may fill by appointment any vacancy in any of the village offices, except vacancy in the office of justice of the peace.

SEC. 2. That section four of said act, approved Feb-Tlective officers ruary twenty-fourth, one thousand eight hundred and seventy, be amended by inserting in the fifth line after the word peace, and before the word of, the words "assessor, constable and clerk."
