CHAPTER XCIII.

February 17,1871 An Act relating to Taxes in the county of Kandiyohi for the year of one thousand eight hundred and seventy.

- SECTION 1. Assessment on all property in said countles declared valid,
 - 2. Extension of time for collection of taxes.
 - 3. When Treasurer to make return to Auditor a list of delinquent taxes-duty of Auditor.
 - 4. Where delinquent tax sale to be held.
 - 5. When act to take effect.

Be it enacted by the Legislature of the State of Minnesota:

Validity of assessment,

Section 1. The assessment of all property, real and personal, in the late counties of Monongalia and Kandiyohi for the year one thousand eight hundred and seventy, and the taxes levied thereon for state, county, town and all other purposes as now appear on the duplicates of those counties, and now in the hands of the county auditor, for the consolidated counties of Kandiyohi, are hereby declared to be legal and valid.

Time extended for collection of taxer.

That the time for the collection and payment SEC. 2. of all taxes for said year one thousand eight hundred and seventy, in the consolidated county of Kandiyohi be, and the same is hereby extended to the first day of April, one thousand eight hundred and seventy-one, and no penalty shall attach on account of the non-payment of any tax prior to the said first day of April.

SEC. 3. That between the first and tenth days of April. Dures of Treas- one thousand eight hundred and seventy one, the county treasurer of said county shall return to the auditor of said county a list of all lands in said consolidated county upon which the taxes of the year one thousand eight hundred and seventy shall remain unpaid, and the auditor of said county shall cause said list (with a notice attached thereo as required by law) to be published for four successive weeks prior to the first Monday in June, one thousand

eight hundred and seventy-one, in a newspaper published at Litchfield, in the county of Meeker.

SEC. 4. That the delinquent tax sale for the taxes of where sale to be the year one thousand eight hundred and seventy shall be held. held at the office of the county auditor, at the time and in the manner provided by law.

SEC. 5. This act shall take effect and be in force from when act to take

and after its passage.
