## CHAPTER CVIII.

An Act to Appropriate Money for the Support of the State March 4, 1872. Normal Schools.

Section 1. Additional appropriation to first state normal school at Winona,

- 2. Additional appropriation to second state normal school at Mankato.
- 3. Additional appropriation to the third state normal school at St. Cloud.
- 4. Warrants to be drawn by the state auditor for the foregoing appropriations.

## Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. There is hereby appropriated out of any money in the state treasury not otherwise appropriated, the First normal sum of five thousand dollars for the year one thousand school. eight hundred and seventy-two, and additional to the sum now annually appropriated for the support of the first state normal school at Winona, the same to be paid on warrants drawn by the president of the state normal school board and countersigned by the secretary thereof.

There is hereby appropriated out of any money in the state treasury not otherwise appropriated, the sum of school. four thousand dollars for the year one thousand eight hundred and seventy-two, and additional to the sum now appropriated for the support of the second state normal school at Mankato, the same to be paid on warrants drawn by the president of the state normal school board and countersigned by the secretary thereof.

Sec. 3. There is hereby appropriated out of any money in the state treasury not otherwise appropriated, the sum of one thousand dollars for the year one thousand eight hundred and seventy-two, and additional to the sum now appropriated for the support of the third state normal school at St. Cloud, the same to be paid on warrants drawn by the president of the normal school board and countersigned by the secretary thereof.

Third normal

Sec. 4. Upon the presentation of such warrants to the state auditor, he shall forthwith draw warrants on the state treasurer for the amount named in the warrants of said Warrants to be drawn by the state auditor. president and secretary not exceeding in all the said sum of five thousand dollars for said first state normal school and the said sum of four thousand dollars for said second state normal school, and the said sum of one thousand dollars for said third state normal school and the money drawn upon said warrants shall be expended under the direction of the state normal board of instruction, as provided by law and for the support of said state normal schools.

This act shall be in force from and after its passage.

## CHAPTER CIX.

Fobruary 27,

An Act to Appropriate Money to Pay Indebtedness of First State Normal School for Insurance.

Section 1. Appropriation to pay insurance on state normal school building at Winona.

2. When act to take effect.

## Be it enacted by the Legislature of the State of Minnesota:

Appropriation for insurance first normal school.

Section 1. There is hereby appropriated out of any money in the state treasury, not otherwise appropriated, the sum of twelve hundred and eighty-two dollars and fifty cents, to be expended in paying indebtedness due on account of insurance on buildings, the same to be paid on warrants drawn by the president of state normal school board and countersigned by the secretary thereof.

Upon presentation of such warrants to the state auditor he shall forthwith draw warrants on the state treasury for the amount named in the warrants of the said president and secretary not exceeding in all the said sum of twelve hundred and eighty-two dollars and fifty cents, and the money
