Thirty-sixth district changed.

The thirty-sixth district shall be composed of the counties of Sibley and McLeod, and shall be entitled to elect one senator; and the towns of Sibley, Kelso, Henderson, Dryden, Arlington, Jessenland, Washington Lake and Faxon, in the county of Sibley, shall be entitled to elect one representative; and the towns of New Auburn and Green Isle, in the county of Sibley and the towns of Glencoe, Helen, Bergen, Rich Valley, Hale and Winsted, in the county of McLeod, shall be entitled to elect one representative, and all the balance of the counties of McLeod and Sibley lying west of the line between range twenty-eight and twenty-nine, shall be entitled to elect one representative.

SEC. 2. This act shall take effect and be in force from

and after its passage.

CHAPTER XCV.

February 27, 1872.

An Act authorizing the Adjutant General to complete the Revision and Correction of the War Record of Minnesota Soldiers, and Appropriating Money for said Purpose.

Section 1. Completion of revision of war record of Minnesota soldiers authorized.

2. Appropriation to the adjutant general therefor.

Be it enacted by the Legislature of the State of Minnesota:

Appropriation for completion of war record.

Section 1. That the adjutant general is hereby authorized and empowered to continue, and complete the revision and correction of the war record of Minnesota soldiers, in accordance with the provisions of section one, of chapter twelve, of the general laws of 1871.

Sec. 2. That for the purpose set forth in section one of

this act, the sum of twelve hundred (1200) dollars, or so much thereof as is necessary be, and the same is hereby appropriated out of any money in the treasury not otherwise appropriated.

This act shall take effect and be in force from Sec. 3.

CHAPTER XCVI.

An Act to aid Citizens of Minnesota who have suffered Loss or Damage of Property by Fire and Storm duing the Summer and Fall of 1871.

> February 29. 1872.

- Section 1. Provides for an appropriation of money for relief of certain citizens.
 - 2. Proceedings to entitle parties to relief.
 - 2. County auditors to forward statements of claims allowed to the governor.
 - 4. The governor required to consolidate these statements and file copy with state auditor.
 - 5. The state auditor to issue certificates for said claims.
 - 6. The certificates to be forwarded to the several county treasurers.
 - 7. Amount of appropriation.
 - 8. Provides for a ratio distribution if claims exceed appropriation.
 - 9. When act to take effect.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. There is hereby appropriated, for the relief of certain citizens in the several counties of this state, who have suffered loss or damage to property by fire or storm by are and hail. during the summer and fall of the year 1871, a limited amount of money as hereinafter specified to enable them to purchase seed wheat or other grain and for no other purpose whatever, for the present year.
