

## CHAPTER CXLI.

AN ACT TO APPROPRIATE MONEY TO PAY THE MEMBERS OF THE FIRST REGIMENT MINNESOTA NATIONAL GUARD FOR SERVICES IN THE BLUEBERRY EXPEDITION.

*Be it enacted by the Legislature of the State of Minnesota :*

SECTION 1. That the sum of six hundred dollars is hereby appropriated out of any money in the treasury belonging to the general revenue fund, or so much thereof as may be necessary, to pay the members of the first regiment Minnesota National Guard, for military service performed in the "Brainerd expedition," in pursuance of section two special orders No. eighty, from the commander-in-chief, dated St. Paul, July twenty-fourth, one thousand eight hundred and seventy-two.

SEC. 2. That the adjutant general shall require, as evidence of such service, duly certified muster and pay rolls, embracing the name, rank and service performed of each claimant, and upon such proof shall draw his order upon the state auditor, who, upon the approval of the governor, shall issue his warrant upon the state treasurer for the payment of such claims.

SEC. 3. This act shall take effect and be in force from and after its passage.

## CHAPTER CXLII.

AN ACT TO APPROPRIATE MONEY TO REIMBURSE THE COUNTY OF TODD FOR EXPENSES INCURRED IN THE CARE OF A NON-RESIDENT SICK PERSON.

*Be it enacted by the Legislature of the State of Minnesota :*

SECTION 1. That the sum of seventy-two dollars and fifty cents be and the same is hereby appropriated out of any money in the treasury of the state of Minnesota not otherwise appropriated, to reimburse the county of Todd, in said state of Minnesota, for expenses incurred in the care and burial of Ole Burnson, a non-resident, who died of small-pox in said county in the month of June, A. D. eighteen hundred and seventy-two, and that the state auditor draw his warrant on the state treasurer in favor of the county of Todd for said amount.

SEC. 2. This act shall take effect and be in force from and after its passage.

## CHAPTER CXLIII.

AN ACT TO REIMBURSE THE COUNTY OF BROWN FOR EXPENSES INCURRED IN PROSECUTING CRIMINALS IN NICOLLET, REDWOOD AND BLUE EARTH COUNTIES.

*Be it enacted by the Legislature of the State of Minnesota:*

SECTION 1. That the sum of three thousand and seventy-nine dollars be and the same is hereby appropriated out of any money in the state treasury not otherwise appropriated to reimburse the county of Brown the amount of expenses incurred in the counties of Nicollet, Redwood and Blue Earth, in the prosecution of criminals from the said county of Brown, during the years one thousand eight hundred and sixty-seven to one thousand eight hundred and seventy, and that the auditor of state draw a warrant on the state treasurer in favor of said county for said amount.

County of Brown

Expenses of prosecuting criminals in adjoining counties.

SEC. 2. Said county of Brown shall use said money for the payment of said indebtedness to said counties of Nicollet, Redwood and Blue Earth, and for no other purpose.

How money to be used.

SEC. 3. This act shall take effect and be in force from and after its passage.
