CHAPTER XXIV.

AN ACT TO PREVENT THE DESTRUCTION OF FISH. DURING CERTAIN MONTHS. IN THE COUNTY OF WATONWAN.

Be it enacted by the Legislature of the State of Minnesota:

Unlawful to figh - with scine or trap

Section 1. It shall be unlawful for any person, at any time during the year to use any seine or trap of any kind whatever, in fishing in Long Lake, Mary's Lake or Kenzie Lake, in the county of Watonwan, or in any inlet or outlet thereof within the county of Watonwan.

SEC. 2. It shall be unlawful at any time during the months of March and April to use the hook, spear or net in fishing in any of the waters aforesaid, their inlets or outlets: Provided, That nets with meshes not more than one and one-half inches square, may be used at any time except the said months of March and April.

Penalty for violating statute.

Unlawful to fish during March and April,

Sec. 3. Any person who shall violate any of the provisions of the preceding sections, shall, upon conviction thereof, pay a fine of five dollars for each and every fish so caught, killed or destroyed, together with the costs of prosecution.

Prosecutions commenced, when.

All prosecutions under the provisions of this chapter shall be commenced within one month from the time when the offense was committed, and the same shall be upon complaint, under oath, before any justice of the peace of said county, and all fines imposed and collected under this act, shall be paid, one-half to the complainant and one-half into the treasury of said county. for the use of the common schools within the same.

Duty of consta-

It shall be the duty of all constables of said SEC. 5. county having knowledge of the violation of any of the provisions of this act, to make complaint thereof to any bles and justices, justice of the peace therein, and any other person having such knowledge may make complaint before any such justice, and the said justice shall issue his warrant for the arrest of such offender, and proceed to hear and determine the matter in issue, in the same manner as provided in other cases, and any person convicted under any of the provisions of this act shall stand committed until the fine

is paid: Provided, That such imprisonment shall not exceed one month.

SEC. 6. This act shall take effect and be in force from Actuakes effect. and after its passage.

CHAPTER XXV.

AN ACT TO PREVENT THE DESTRUCTION OF FISH FROM THE WATERS WITHIN THE COUNTIES OF DOUGLAS, TODD, WIL-KIN, TRAVERSE, POLK, CLAY, CASS, BELTRAMI AND PEMBINA.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. It shall be unlawful for any person to catch, kill, destroy, spear, or in any manner, except by Unlawful to take hook and line, to take any fish, of any kind or description how. when and whatever, from any lake, pond or marsh, or inlet or outlet thereof, or other waters situated and being within the boundaries of the counties of Douglas, Todd, Wilkin, Traverse, Polk, Clay, Cass, Beltrami or Pembina, from the fifteenth day of April to the fifteenth day of May in any year after the passage of this act.

SEC. 2. Any person or persons violating the provisions of the preceding section, shall upon conviction thereof, suffer and pay a fine of five dollars for each and every latter of statute. fish so caught, killed, destroyed or taken, together with the costs of prosecution.

Sec. 3. All prosecutions under the provisions of this act shall be commenced within one month from the time Prosecutions. when the offense was committed, in the same manner provided in section ten of chapter thirty-three of the general laws of the state of Minnesota for the year A. D. one thousand eight hundred and seventy-one.

SEC. 4. It is hereby made the duty of supervisors and constables of towns, and of all others residing or being but of mpervi-within said counties, having knowledge of the violation bles. of any of the provisions of this act, to make complaint thereof to any justice of the peace within the county
