CHAPTER XLIII.

AN ACT TO PROVIDE FOR THE PAYMENT OF SHERIFFS AND THEIR DEPUTIES, WHILE IN ATTENDANCE UPON COURT, AND THE COMPENSATION OF JAILORS AND TURNKEYS.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That on or before the holding of any term of the district courts, or courts of common pleas, of this peputy Shering state, the judge thereof shall determine and fix by his attending court, their number and order the number of deputies which shall be necessary pay. for the sheriff of that county to have in attendance upon such term of court; and thereupon such sheriff shall designate and appoint such deputies. Such deputies, appointed as aforesaid, shall be paid their per diem, to be determined by the court, for attendance upon such court in the same manner as provided by law for the payment of grand and petit jurors.

SEC. 2. The judge of the district court for each county shall also determine, from time to time, the compensation compensation of that shall be allowed for the services of a jailor, or turn-termined and key, in the county jail; which compensation shall be paid paid. monthly out of the county treasury upon the warrant of the county auditor. Such jailor or turnkey to be appointed by the sheriff of such county, subject to the approval

of the judge.

SEC. 3. This act shall take effect and be in force from Act takes effect. and after its passage.

CHAPTER XLIV.

AN ACT TO AMEND SECTION NINETY-TWO, CHAPTER EIGHT OF THE REVISED STATUTES OF THE STATE OF MINNESOTA, RELATING TO COUNTY COMMISSIONERS.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That section ninety-two of chapter eight, title three, of the revised statutes, be and the same is

hereby amended so as to read as follows:

Pay of county commissioners.

Sec. 92. The county commissioners shall each receive three dollars per day for each day they are necessarily employed in transacting the county business, and ten cents per mile for every mile traveled in going to and returning from the meeting of the county board in the discharge of any official duty, computed by the nearest traveled route, but no county commissioner shall receive pay for more than twenty days in any one year, or be entitled to traveling fees for attendance on more than six sessions in any one year.

CHAPTER XLV.

AN ACT TO AMEND SECTION ONE HUNDRED AND ONE, CHAPTER EIGHT, OF THE REVISED STATUTES, RELATING TO THE DUTIES OF THE COUNTY COMMISSIONERS.

Be it enacted by the Legislature of the State of Minnesota;

SECTION 1. That section one hundred and one, chapter eight, of the revised statutes of this state, is hereby amended by inserting next after the word "sheriff" in the second line of said section, the words "the judge of probate."
