

CHAPTER CXXXVII.

AN ACT TO APPROPRIATE MONEY TO THE COUNTY OF WRIGHT, FOR THE PURPOSE OF AIDING IN THE CONSTRUCTION OF ROADS AND BRIDGES.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That the sum of one thousand dollars be and the same is hereby appropriated out of any money in the state treasury belonging to the "internal improvement fund" of said state not otherwise appropriated, to aid in the opening, repairing and construction of a road from the town of "Silver Creek" in said Wright county, to the town of Hassen, in Hennepin county, and state aforesaid. Said sum of money to be expended by and under the direction of the following commissioners, hereby appointed for that purpose, namely: Milton Bliss, of the town of Monticello, Nelson J. Locke, of the town of Silver Creek, and Stephen Shumaker, of the town of Frankfort, all of said county of Wright.

SEC. 2. Said money shall be paid to the county treasurer of said county of Wright by the state treasurer, upon the warrant of the state auditor out of said fund if in his hands, and if not in his hands, then out of the first money which shall come into his hands belonging to said fund, and which shall not have heretofore been appointed, and when so paid over to said county treasurer that officer shall hold the same subject to the order of said commissioners heretofore named, and shall disburse and pay out the same upon the order or orders of the aforesaid commissioners.

SEC. 3. Whenever there is any money in the state treasury belonging to said fund not heretofore appropriated, the state auditor shall on demand of the said county treasurer draw his warrant upon the state treasurer and in favor of said county treasurer for the amount herein appropriated, and upon presentation of said warrant, the state treasurer shall pay over the same to the said county treasurer.

SEC. 4. Said commissioners are to expend the said sum of money on that portion of said road lying between the aforesaid town of Hassen, in said Hennepin county, and the farm now owned and occupied by George Coombs, in the aforesaid town of Silver Creek, in said Wright county. *Provided*, That this act shall not be so construed so as to prevent the aforesaid commissioners from paying out

of said sum of one thousand dollars the sum of two hundred dollars to the town supervisors of the town of Cokato, for the purpose of aiding in the construction of a bridge across the Crow river, on section eleven, town one hundred and nineteen, range twenty-eight, at a point where the state road from Glencoe to Fairhaven crosses the said Crow river, and for no other purpose.

SEC. 5. The auditor, treasurer and register of said Wright county acting jointly, are hereby authorized and empowered to appoint a proper person to act in the place and stead of any or either of the commissioners named in section one of this act, in case any or either of them should fail for any cause to accept the appointment therein conferred upon them or to perform the duties required of them by this act.

SEC. 6. This act shall take effect and be in force from and after its passage.

CHAPTER CXXXVIII.

AN ACT TO APPROPRIATE MONEY TO BUILD A BRIDGE ACROSS THE REDWOOD RIVER AT LYND, LYON COUNTY.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That the sum of five hundred dollars, or so much thereof as may be necessary, is hereby appropriated out of any money in the treasury belonging to the internal improvement fund, or out of the first moneys which may come into the treasury belonging to said fund, to build a substantial bridge across the Redwood river at Lynd, Lyon county, at such crossing of said river as the commissioners of said county or a majority of them may designate.

SEC. 2. That said bridge shall be built under the direction of the board of county commissioners of said county of Lyon, and no part of said appropriation shall be paid until said bridge is completed and ready for use.

SEC. 3. That Henry Langdon, T. T. Pierce and Charles Marsh, of said county are hereby appointed a committee on the part of the state to view said bridge when completed and examine all contracts, vouchers and accounts relating thereto, and the cost thereof, and to
