SECTION. 1. That section one be and is hereby amended so as to read as follows:

All of section twenty-six (26) except the north one-half of the north-east quarter, south half of section twenty-seven (27), south-east quarter of section twenty-eight (28), east half of section thirty-three, and all of sections thirty-four (34) and thirty-five (35) in township one hundred and eight (108) north, of range twenty-four (24), and all of section three (3) in township one hundred and seven (107) north, of range twenty-four (24) west, in Waseca county, in the state of Minnesota, shall be known as the village of East Janesville, and by that name may sue and be sued, make contracts, purchase, take and hold real and personal property, and have corporate seal alterable at pleasure. Every grant and devise of lands, or right, or transfer of property which has been or may be made for the benefit of its inhabitants, shall have the same effect as if made to the village by name.

SEC. 2. That section seven (7) be amended by adding at the end

thereof as follows:

Sixteenth—To prevent drunkenness and disorderly behavior. The trustees may provide for a fine for the violation of an ordinance on this subject, and may also authorize the court to imprison in the village jail or lock-up, not exceeding five days, in lieu of a fine.

SEC. 3. All acts or parts of acts inconsistent with this act, are

hereby repealed.

Sec. 4. This act shall take effect and be in force from and after its passage.

CHAPTER XXIV.

AN ACT TO AMEND SECTION EIGHTEEN OF THE CHARTER OF THE VILLAGE OF WASECA, AS AMENDED BY CHAPTER FOUR OF THE SPECIAL LAWS OF ONE THOUSAND EIGHT HUNDRED AND SEVENTY-ONE.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That section eighteen of chapter four of the special laws of one thousand eight hundred and seventy-one, be amended so as to read as follows:

Sec. 18. The said village of Waseca shall constitute one school

district, under the general school laws of this state, and the annual meeting shall be held on the first Tuesday of August in each year for the election of school officers, and the term of office of such officers shall commence on the twelfth day of the month in which they are elected; *Provided*. That any school district or part of school district adjacent to said village may by a majority vote of the electors of such school district or part of school district, and of said village, unite with said village in organizing an independent school district, or said village may by a like vote, organize into an independent school district under the general laws of this state.

SEC. 2. This act shall take effect and be in force from and after

its passage.

CHAPTER XXV.

AN ACT TO AMEND SECTION TWO OF CHAPTER EIGHT OF THE SPECIAL LAWS OF THE YEAR A. D. EIGHTEEN HUNDRED AND SEVENTY-ONE, CHARTER OF THE VILLAGE OF CHASKA.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. That section two of chapter eight of the special laws of the year A. D. eighteen hundred and seventy-one, be, and the

same are hereby amended so as to read as follows:

Sec. 2. The management of its municipal concerns shall be vested in five trustees, one of whom shall be selected by them as president, a clerk, treasurer, and marshal, and such other officers as the trustees may create and appoint. The terms of all officers shall commence on the third Tuesday in May, and shall continue for one year (unless elected or appointed to fill a vacancy), and until their successors are elected and qualified. All officers shall be residents of the village, and the trustees and treasurer must be freeholders thereof, and all officers shall, before entering upon the discharge of the duties of their respective offices, each take and subscribe an oath to faithfully and honestly discharge the duties of their office, which said oath of office shall be filed with the clerk of said village.

SEC. 2. This act shall take effect and be in force from and after

its passage.
