

CHAPTER LII.

AN ACT TO DETACH CERTAIN TERRITORY FROM SCHOOL DISTRICT NUMBER ONE, (1) IN OLMSTED COUNTY, AND ATTACH THE SAME TO CHATFIELD SCHOOL DISTRICT.

Be it enacted by the Legislature of the State of Minnesota :

SECTION 1. That the north half of section thirty-one (31) in township one hundred and five (105) north, of range eleven (11) west, be and the same is hereby detached from school district number one, (1) in Olmsted county, and attached to Chatfield school district.

SEC. 2. This act shall take effect and be in force from and after its passage.

CHAPTER LIII.

AN ACT TO AUTHORIZE THE COUNTY COMMISSIONERS OF FARIBAULT COUNTY TO CHANGE THE BOUNDARIES OF INDEPENDENT SCHOOL DISTRICT OF BLUE EARTH CITY IN SAID COUNTY.

Be it enacted by the Legislature of the State of Minnesota :

SECTION 1. The county commissioners of the county of Faribault be and they are hereby authorized to change the boundaries of independent school district of Blue Earth City as hereinafter provided in section two (2) and three (3) of this act, and in no other manner whatever; that is to say, by detaching the following described real estate or any portion thereof from said district and attaching the same to any other district in said county, as shall seem just and proper for them so to do, which real estate so to be detached is described as follows, to-wit: The south-east quarter of section twenty, (20) the north-west quarter of section twenty-one, (21) the southeast quarter of section twenty-one, (21) the south-west quarter of section twenty-one, (21) the north-east quarter of section twenty-one, (21)

the north-west quarter of section twenty-two, (22) the south-west quarter of section twenty-two, (22) all in town one hundred and two, (102) range twenty-seven (27).

SEC. 2. Any one or more freeholders being legal voters of the territory to be affected thereby, may file a statement with the county auditor to the effect that at the session of the board of county commissioners next ensuing after twenty days from the passage of this act, he or they shall present a petition to said commissioners praying to have some portion or all of the territory described in section one of this act detached from the independent school district of Blue Earth City, and thereupon it shall be the duty of the auditor to cause a notice thereof to be published at least six days prior to the meeting of the board of commissioners, in a newspaper printed and published in the school district of Blue Earth City, which notice shall specify the name of the person or persons filing such statement, the amount and description of territory proposed to be detached in each, the day on which said board of county commissioners will meet, and that at the session of said board the commissioners will determine whether said territory or any part thereof shall be detached or not.

SEC. 3. At the time of the meeting of the board of county commissioners mentioned in the notice published by the county auditor as in section two of this act provided, and upon presentation to said board of the petition or petitions described in the statement or statements previously filed in the auditor's office, signed *only* by freeholders who are legal voters and residents of the territory to be affected by the change, said board of commissioners may detach any portion or all of said territory, as in their judgment shall be for the best interest of all parties concerned. *Provided*, That if it shall appear by remonstrance signed by a majority of the legal voters being freeholders and residents of the territory to be affected by the change asked for in said petition or petitions, which remonstrance must be presented to the board of commissioners at the time stated in the notice published by the auditor for the hearing of said petitions, that they are opposed to the change asked for by any of the petitions, or to all of them, and that they are opposed to any change of the boundaries in any manner whatever, then and in that case the commissioners shall not alter or change the boundaries of said district.

SEC. 4. This act shall take effect and be in force from and after its passage.
