## CHAPTER CIV.

AN ACT TO APPROPRIATE MONEY FOR THE PURPOSE OF VENTILATING THE SENATE CHAMBER AND THE HALL OF THE HOUSE OF REPRESENTATIVES, AND FOR RENT OF GOVERNOR'S HOUSE.

*Be it enacted by the Legislature of the State of Minnesota:*

SECTION 1. That the sum of fifteen hundred dollars, or so much of it as may be necessary, be and is hereby appropriated to be expended by direction of the governor for the purpose of constructing for open [proper] ventilating apparatus for the senate chamber and hall of the house of representatives.

Appropriation for ventilating capitol.

SEC. 2. That the sum of eight hundred dollars is hereby appropriated for rent of governor's house.

For rent of governor's house.

SEC. 3. This act shall take effect and be in force from and after its passage.

When act to take effect.

## CHAPTER CV.

AN ACT TO AID THE DESTITUTE SETTLERS UPON THE FRONTIER, AND TO APPROPRIATE MONEYS THEREFOR.

*Be it enacted by the Legislature of the State of Minnesota:*

Appropriation  
for relief of des-  
titute on frontier

SECTION 1. That the sum of five thousand dollars, or so much thereof as may be necessary, be and the same is hereby appropriated out of any fund [funds] in the state treasury not otherwise appropriated, for the relief of the destitute inhabitants and settlers upon the frontier.

How expended.

SEC. 2. That the sum above appropriated shall be expended and disbursed under the supervision and direction of the governor and at his discretion.

When act to take  
effect.

SEC. 3. This act shall take effect and be in force from and after its passage.

## CHAPTER CVI.

AN ACT TO APPROPRIATE MONEY REQUIRED BY LAW TO BE INVESTED IN INTEREST BEARING BONDS.

*Be it enacted by the Legislature of the State of Minnesota:*

Investment of  
funds received  
into the state  
treasury.

SECTION 1. There is hereby annually appropriated all moneys received into the state treasury to the credit of the permanent school fund, permanent university fund, internal improvement land fund, sinking fund, inebriate asylum fund, or other funds required to be invested in securities, to be invested in interest bearing bonds, of the United States or of the state of Minnesota issued since the year eighteen hundred and sixty, or of the bonds bearing not less than six per cent. interest of the states of Massachusetts, New York, Pennsylvania, Ohio, Indiana, Illinois, Wisconsin, Michigan, Missouri and Iowa, and the state auditor is hereby authorized to draw warrants on the treasurer [treasury] therefor.

When act to take  
effect.

SEC. 2. This act shall take effect and be in force from and after its passage.
