CHAPTER CXXVIII.

AN ACT TO APPROPRIATE MONEY FOR CERTAIN PURPOSES.

Be it enacted by the Legislature of the State of Minnesota;

Appropriation for certain purSECTION 1. That the sum of seventy-five 44-100 dollars be and the same is hereby appropriated to Lorenzo Hoyt out of any moneys in the state treasury not otherwise appropriated, to reimburse him for money expended in the contested election case of H. J. Brainard against Lorenzo Hoyt for a seat in the house of representatives for the year eighteen hundred and seventy-four, from the twenty-fourth senatorial and representative districts.

SEO. 2. That the further sum of seventy-seven 75-100 dollars be and the same is hereby appropriated to Walter McArthur to reimburse him for his expenses in the contested election case of McArthur against Beard.

When act to take effect. SEC. 3. This act shall take effect and be in force from and after its passage.

CHAPTER CXXIX.

AN ACT TO APPROPRIATE MONEY FOR CERTAIN PURPOSES THEREIN NAMED.

Be it enacted by the Legislature of the State of Minnesota;

Appropriation for tertain purposes.

SECTION 1. That the following sums of money, or so much thereof as may be necessary, be and the same are hereby appropriated out of any money in the treasury belonging to the general revenue fund, not otherwise appropriated:

1st.—For the payment of certificates issued by the senate for mileage, per diem of the members and officers of the senate, and for the payment of other expenses while sitting as a court of impeachment in May, eighteen hundred and seventy-three (1873), four thousand dollars (\$4,000).

2d.—For payment of balance due state printer for work done by contract for state in eighteen hundred and seventy-three (1873), ten thousand seven hundred and thirty-six 23-100 dollars (\$10,736.23).

3d.—For payment of balance due for publishing general laws of eighteen hundred and seventy-three (1873), in newspapers, fifteen hundred and seventy-seven 25.100

dollars (\$1,577.25).

4th.—For payment of amount due for advertising for the various state departments in eighteen hundred and seventy-three (1873), one thousand dollars (\$1,000).

5th.—This act shall take effect and be in force from and after its passage.

CHAPTER CXXX. .

AN ACT TO APPROPRIATE MONEY FOR THE PURPOSES THEREIN NAMED.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That the sum of six hundred dollars To buy a safe (\$600) or so much thereof as may be necessary is hereby of careculare appropriated for the purpose of buying a safe for the executive office. Said sum to be paid out of the treasury upon the order of the governor.

SEC. 2. This act shall take effect and be in force from when act to take and after its passage.
