A copy of any such official bond so filed in the office of the secretary of state, and duly certified by him under his hand and seal of office to be a true copy of the original bond or on lile in his office may be used as evidence in all the courts of this state, and shall have the same force and effect as if the original bond were produced in court.

CHAPTER XC.

Judge to be appointed.

A district judge shall be elected therefor at Sec. 3. the next general election, and the governor is hereby authorized to fill the vacancy by appointment until such election and the qualification of the elected judge according to law.

SEC. 4. All acts and parts of acts inconsistent with Repeal of inconelatent acts. this Act are hereby repealed.

CHAPTER XCI.

AN ACT TO DETACH THE COUNTY OF ROCK FROM THE COUNTY OF NOBLES FOR JUDICIAL PURPOSES, AND TO ORGANIZE THE SAME FOR JUDICIAL PURPOSES, AND TO PROVIDE FOR GENERAL TERMS OF THE DISTRICT COURT THEREIN.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That the county of Rock is hereby detached trom the county of Nobles for judicial purposes, from Nobles. and is hereby declared to be organized for judicial purposes, with all the rights, privileges and immunities of counties of this state organized for judicial purposes.

SEC. 2. General terms of the district court shall be Term of court held in and for said county of Rock on the first Tuesday

of April in each year.

Sec. 3. All judicial proceedings now pending in, and all recognizances and writs returnable to the district court All proceedings in the county of Nobles from the county of Rock shall be returnable to made pending in and returnable to the district court in said county of Rock, and all papers on file with the clerk of the district court in said Nobles county which appertain unto said county of Rock shall be immediately transferred to the clerk of said court in said Rock county, and all records in the office of the clerk of the district court of said Nobles county which appertain unto said Rock county shall be transcribed and recorded in the office of the clerk of the district court in said Rock county.
