

CHAPTER XCV.

AN ACT TO CHANGE THE TIME OF HOLDING GENERAL TERMS OF THE DISTRICT COURT IN THE COUNTY OF MOWER, TENTH JUDICIAL DISTRICT.

Be it enacted by the Legislature of the State of Minnesota:

Term of court fixed in Mower county.

SECTION 1. The general terms of the district court in and for the county of Mower, tenth judicial district, shall be held on the first Tuesday in March, and the third Tuesday in September.

All proceedings returnable to said term.

SEC. 2. All writs, recognizances and all other papers and proceedings made returnable to the district court of said county, shall be considered and be deemed to be returnable to the terms of said court as fixed by this act, and all continuances, appeals and motions, notices or other proceedings taken or made to or for any term of said court, shall be considered and construed to be made or taken to the terms of said court as fixed by this act.

Repeal of inconsistent acts.

SEC. 3. All acts and parts of acts inconsistent with this act are hereby repealed.

When act to take effect.

SEC. 4. This act shall take effect and be in force from and after its passage.

CHAPTER XCVI.

AN ACT TO AMEND SECTION ONE OF CHAPTER FORTY-SEVEN OF THE GENERAL LAWS OF MINNESOTA FOR EIGHTEEN HUNDRED AND SEVENTY-TWO, CHANGING THE TERM OF DISTRICT COURT OF THE COUNTY OF BENTON.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That section one of chapter forty-seven

of the general laws of Minnesota for 1872 be amended by striking out the word "last" in that part of said section relating to the term of district court in Benton county, and substituting the word "second" in lieu thereof.

Term of court fixed in Benton county.

SEC. 2. This act shall take effect and be in force from and after its passage.

When act to take effect.

CHAPTER XCVII.

AN ACT TO CHANGE THE TIME OF HOLDING THE SEVERAL TERMS OF THE DISTRICT COURT IN AND FOR THE COUNTY OF WASECA, IN THE FIFTH JUDICIAL DISTRICT.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. The general terms of the district court in and for the county of Waseca, in the fifth judicial district, shall be held on the third Tuesday in March, and the third Tuesday in October in each year.

Term of court fixed in Waseca county.

SEC. 2. All writs, recognizances and all other proceedings made returnable to the district court of said county, shall be considered and deemed to be returnable at the terms of said court as fixed by this act, and all continuances, appeals, motions, notices and all other proceedings, taken or made to or for any term of said court, shall be considered and construed to be made or taken to the terms of said court, as fixed by this act.

All proceedings returnable to said term.

SEC. 3. All acts and parts of acts inconsistent with this act are hereby repealed.

Repeal of inconsistent acts.

SEC. 4. This act shall take effect and be in force on and after its passage.

When act to take effect.
