CHAPTER CXXIII.

AN ACT TO PREVENT SWINE FROM RUNNING AT LARGE WHERE DAMAGE MAY BE DONE, IN THE TOWN OF SCAMBLER, OTTER TAIL COUNTY, AND THE TOWNS AD-JOINING.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That it shall be unlawful for any person or per-Prohibiting the sons to allow any swine by him or them owned, or which may be in his or their possession, or under his or their control, to run at large upon the lands of any other person at any season of the year, when such swine by so running would do any damage to crops of any kind within the town of Scambler, in Otter Tail county, and towns adjoining thereto, to the aforesaid town.

> SEC. 2. Whoever willfully or negligently permits any swine which may be in his possession, or under his control, or which he may own, to run at large upon the lands of any other person as mentioned in the preceding section, and within the towns therein mentioned, after having been notified in writing, shall be guilty of misdemeanor, and upon conviction thereof shall pay a fine of not less than one dollar, and not to exceed the sum of five dollars for each offense.

> SEC. 3. Each day upon which any swine in the preceding section mentioned is permitted to run at large, in the places and under circumstances in said section mentioned, shall constitute a distinct and separate offense within the meaning of this act.

CHAPTER CXXIV.

SECTION 1. That it shall be unlawful for any person or persons to allow any cattle, horses, sheep, swine or other domestic animals larger than sheep, owned by such person or p or of which such person or persons have control or ma possession, to run at large upon any public highway, ou pon running at the lands of any other person or persons, in the county of cattle, ac. Mower, state of Minnesota, during any season of the year, unless they are carefully herded.
