CHAPTER CXIV.

AN ACT TO APPROPRIATE MONEY FOR THE PAYMENT OF IN-TEREST ON STATE LOANS.

Be it enacted by the Legislature of the State of Minnesota:

Appropriation SECTION I. That the sum of thirty-five thousand dollars, be for state interest. and the same is hereby appropriated out of any money in the state treasury belonging to the state interest fund, to be expendeffect.

SEC. 2. This act shall take effect and be in force from and after its passage.

CHAPTER CXV.

AN ACT TO APPROPRIATE MONEY FOR CERTAIN PURPOSES.

Be it enacted by the Legislature of the State of Minnesota :

Appropriation for certain purSECTION 1. That the following sums of money or so much thereof as may be necessary, be and the same are hereby appropriated out of any money in the state treasury belonging to the general revenue fund not otherwise appropriated :

5th.-For payment of amounts due for repairing and furnishing the capitol building in eighteen hundred and seventyfive, two thousand six hundred and fifty-one 85-100 dollars (\$2,651.85).

6th.—For payment of amounts due Sherwood Hough, John C. Shaw and W. P. Jewett for administering oaths in bounty and pension claim cases, in eighteen hundred and seventy-five, ninety-two 25-100 dollars (\$92.25).

CHAPTER CXVI.

AN ACT TO APPROPRIATE MONEY FOR THE GENERAL EX-PENSES OF THE STATE GOVERNMENT FOR THE VEAR EIGHTEEN HUNDRED AND SEVENTY-SIX.

Be it enacted by the Legislature of the State of Minnesota:

Appropriation for general expenses, SECTION 1. That the following sums of money or so much thereof as may be necessary, be and the same are hereby appropriated out of any money in the state treasury belonging to the general revenue fund not otherwise appropriated for the general expenses of the state government for the year eighteen hundred and seventy-six.

1st.—For salaries of judges in addition to amount appropriated by chapter one hundred and fourteen of general laws of eighteen hundred and seventy-four, ten thousand and five hundred dollars (\$10,500).

2nd.—For salary of the janitor in addition to the amount appropriated by chapter one hundred and fourteen of general laws of eighteen hundred and seventy-four, two hundred dollars (\$200):

3d.—For salary of the clerk in the insurance commissioner's office for the year eighteen hundred and seventy-six, one thousand dollars (\$1,000).

4th,—For clerk hire for the governor for the year eighteen hundred and seventy-six, one thousand dollars (\$1,000).

5th.—For executive contingent fund for state purposes and incidental expenses of the governor's office, three thousand dollars (\$3,900).

6th — For incidental expenses of the secretary's office, four hundred dollars (\$400).
