

CHAPTER CI.

AN ACT TO LEGALIZE THE PROCEEDINGS OF A SCHOOL MEETING
IN JACKSON COUNTY.

Be it enacted by the Legislature of the State of Minnesota :

SECTION 1. That the proceedings had and held in district number fifty-two in Jackson county on the second day of October, 1875, be hereby legalized and made valid, and the taxes then levied or voted shall be levied and collected as other taxes are levied and collected.

SEC. 2. This act shall take effect and be in force from and after its passage.

Approved March 1, 1876.

CHAPTER CII.

AN ACT TO LEGALIZE THE ACTION OF A SPECIAL SCHOOL MEETING, HELD IN SCHOOL DISTRICT NUMBER FIFTY-NINE, IN LE-SUEUR COUNTY, CHANGING THE SITE OF THE SCHOOL HOUSE THEREIN, TO FIX THE SITE FOR THE SCHOOL HOUSE IN SAID DISTRICT, AND TO LEGALIZE THE ACTION OF THE TRUSTEES THEREOF IN ISSUING THE BONDS OF SAID DISTRICT, AND TO MAKE THE SAME A LIEN ON THE PROPERTY THEREOF.

Be it enacted by the Legislature of the State of Minnesota :

SECTION 1. That the action of the special school meeting held in school district number fifty-nine, in the county of Le Sueur, on the 13th day of November, 1875, changing the site of the school house in said district, be and the same is hereby legalized and confirmed, and the site for the school house for said school district is hereby fixed at the place where the said meeting located it.

SEC. 2. That the bonds heretofore issued by the trustees of said school district to the amount of five hundred dollars, be and the same are hereby legalized and confirmed, and all taxes which may be levied to pay the said bonds and the interest accruing thereon, shall be levied on all the taxable property now included in said school district, and the said bonds are hereby declared to be a lien on all the taxable property in the territory forming the same.

SEC. 3. This act shall take effect and be in force from and after its passage.

CHAPTER CIII.

AN ACT FOR THE ORGANIZATION OF A SCHOOL DISTRICT IN THE COUNTY OF REDWOOD.

Be it enacted by the Legislature of the State of Minnesota :

SECTION 1. That so much of the county of Redwood, as is embraced in the following territory, bounded as follows: Commencing at a point on the Minnesota river at northwest corner of lot number two, section twenty-nine, township one hundred and thirteen (113), range thirty-five (35), running thence south to the center of said section 29, thence west eighty rods, thence south one hundred and sixty rods to the south line of said section twenty-nine, thence east on said section line to the Minnesota river, being the southeast corner of lot number one, section twenty-six, town one hundred and thirteen, range thirty-five, thence up the river to the place of beginning, be and the same is hereby constituted as school district for all common school purposes whatsoever, and be subject to the common school laws of this state, and be known as district number twenty-nine, in Redwood county.

SEC. 2. This act shall take effect and be in force from and after its passage.

CHAPTER CIV.

AN ACT TO DETACH CERTAIN TERRITORY FROM SCHOOL DISTRICT NUMBER FIFTY-SIX, IN THE COUNTY OF WINONA, AND ATTACH IT TO AND MAKE IT A PART OF DISTRICT NUMBER SIX, OF HOUSTON COUNTY.

Be it enacted by the Legislature of the State of Minnesota :

SECTION 1. That section thirty-two and the southeast quarter of section thirty-one, in township one hundred and five, of range six, in the county of Winona, be and the same is hereby detached from school
