### CHAPTER XVI.

#### AN ACT TO INCORPORATE THE VILLAGE OF SAUK CENTRE.

# Be it enacted by the Legislature of the State of Minnesota :

SECTION I. All that portion of the township of Sauk Centre, in the county of Stearns, and state of Minnesota, known and described as follows, to-wit: The southwest quarter of section numbered three (3), the southeast quarter of section numbered four (4), the east half of section numbered nine (9), the west half of section numbered ten (10), and the north half of the northwest quarter of section numbered fifteen (15), all in township numbered one hundred and twenty-six (126), north of range numbered thirty-four (34), west of the fifth principal meridian, shall be and is hereby constituted the village of Sauk Centre, under and subject to the provisions of chapter one hundred and thirtynine (139) of the general laws of 1875, and L. L. West, C. Truman, E. P. Barnum, J. D. Carr, Josiah Cooper and Frederick Williams, are designated as the persons to act under section nine (9) of said chapter, in calling the first election in said village.

SEC. 2. The said village of Sauk Centre, shall have two justices of the peace, and two constables, instead of one justice of the peace and one constable, and they shall be elected as provided in section 2 of said chapter.

SEC. 3. The provisions of this act shall take effect and be in force from and after the first day of March, A. D. 1876.

#### CHAPTER XVII.

# AN ACT TO INCORPORATE THE VILLAGE OF DELANO, IN THE COUN-TY OF WRIGHT, STATE OF MINNESOTA.

#### Be it enacted by the Legislature of the State of Minnesota :

SECTION 1. That the following described territory in the county of Wright, in said state, to-wit: The southeast quarter of the northeast quarter (se  $\frac{1}{4}$  of ne  $\frac{1}{4}$ ) and the east half of the southeast quarter (e  $\frac{1}{2}$  of se  $\frac{1}{4}$ ) of section number eleven (11), and the southwest quarter of the northwest quarter (sw  $\frac{1}{4}$  of nw  $\frac{1}{4}$ ) and the west half of the southwest quarter (w  $\frac{1}{2}$  of sw  $\frac{1}{4}$ ) of section number twelve (12), all in township

number one hundred and eighteen (118) north, of range number twentyfive (25) west, be and the same is hereby set apart for incorporation as the village of Delano.

SEC. 2. That the following named persons are designated as commissioners under the general laws of this state, to post notices of the first election in said village, viz: William H. Landis, George T. Mulford and Miner Ball.

SEC. 3. That upon organization as directed in the general laws of this state, the said territory shall constitute the village of Delano, and shall thereupon be endowed with all the rights, powers and duties therein prescribed, or to be prescribed, for organized villages in this state.

SEC. 4. This act shall take effect and be in force from and after its passage.

## CHAPTER XVIII.

# AN ACT TO LEGALIZE THE ACT INCORPORATING THE VILLAGE OF LAKE CRYSTAL; AND PROCEEDINGS THEREUNDER, THE SAME BEING CHAPTER FIVE OF THE SPECIAL LAWS OF EIGHTEEN HUN-DRED AND SEVENTY.

### Be it enacted by the Legislature of the State of Minnesota :

SECTION 1. That the act incorporating the village of Lake Crystal, approved February twenty-fourth, one thousand eight hundred and seventy, the same being chapter five of the special laws of one thousand eight hundred and seventy, shall be held and construed to have taken effect and gone into operation from and after the twenty-second day of March, one thousand eight hundred and seventy; and all acts done by authority thereof, are hereby declared to be legal and valid.

SEC. 2. This act shall take effect and be in force from and after its passage.
