

## CHAPTER CXCII.

## AN ACT TO AUTHORIZE CERTAIN PERSONS TO DRAIN A CERTAIN LAKE IN THE COUNTY OF HENNEPIN.

*Be it enacted by the Legislature of the State of Minnesota :*

SECTION 1. That for the purpose of reclaiming certain swamp lands and rendering the same productive, Peter Ritchie, Jonas Staring and C. B. Tirrell, and such other persons as they may associate with them, are hereby authorized and empowered, after having obtained the consent of all the owners of the lands bordering thereon, to lower the waters of the lake known as Grass Lake, lying in sections thirty-two (32), thirty-three (33), and thirty-four (34), in township number one hundred and sixteen (116), of range number twenty-two (22) west, in the county of Hennepin, to a level with the waters of the Minnesota river, at low water mark, opposite the eastern end of said lake, by the construction of a ditch from some point at or near the east end of said lake to the Minnesota river.

SEC. 2. This act shall take effect and be in force from and after its passage.

## CHAPTER CXCIII.

## AN ACT TO AUTHORIZE THE DRAINAGE OF CERTAIN LAKES IN KANDIYOHI COUNTY.

*Be it enacted by the Legislature of the State of Minnesota :*

SECTION 1. The citizens of the county of Kandiyohi, in this state, owning lands bordering or abutting upon Lake Nevada, Lake Elizabeth, Lake Ringo, Lake Oliver, Solomon Lake and Point Lake, are hereby authorized and empowered to drain said lakes as follows: by lowering the waters of Lake Nevada two feet, and the waters of Lakes Elizabeth, Ringo, Oliver and Meed, four feet each, by draining the waters of Lakes Elizabeth, Oliver and Meed into Lake Ringo, from thence into Solomon or Point Lakes as may be most expedient. *Provided*, That all persons affected by such drainage consent thereto and

file such consent in writing in the office of the register of deeds in and for said county.

SEC. 2. This act shall take effect and be in force from and after its passage.

#### CHAPTER CXCIV.

##### AN ACT TO AUTHORIZE CERTAIN PARTIES TO DRAIN A CERTAIN LAKE IN KANDIYOHI COUNTY.

*Be it enacted by the Legislature of the State of Minnesota :*

SECTION 1. That M. Knudson, T. Torson, A. M. Lunden and B. Hanson and such other persons as they may associate with them, are hereby authorized and empowered, after having obtained the consent in writing of all persons affected, to lower the waters of Peach Lake, lying in sections 8, 17, and 18; town 119, range 34, two feet through its natural outlet into Grass Lake, in Kandiyohi county.

SEC. 4. This act shall take effect and be in force from and after its passage.

#### CHAPTER CXCIV.

##### AN ACT TO AUTHORIZE CERTAIN PARTIES TO DRAIN A CERTAIN LAKE IN KANDIYOHI COUNTY.

*Be it enacted by the Legislature of the State of Minnesota :*

SECTION 1. That for the purpose of reclaiming certain swamp land and rendering the same productive, John Olander, A. Nulen, A. J. Erickson, William Whitney, and such other persons as they may associate with them, are hereby authorized and empowered, after having obtained the consent in writing of all parties interested or who will be affected, and filed the same with the register of deeds of Kandiyohi county, to lower the waters of the lake lying in sections 7 and 18, in town one hundred and twenty-one, range thirty-four, and in section
