# SPECIAL LAWS

# CHAPTER CCIII.

## AN ACT TO AMEND SECTION EIGHT (8) OF CHAPTER TWO (2) OF THE SPECIAL LAWS OF ONE THOUSAND EIGHT HUNDRED AND SEVENTY-ONE (1871), RELATING TO JUSTICE OF THE PEACE.

### Be it enacted by the Legislature of the State of Minnesota ;

SECTION I. That section eight of chapter two of the special laws of eighteen hundred and seventy-one, be and the same is hereby amended by adding to said section eight of chapter two the following words, to-wit: "The justice of the peace provided for and elected under the provisions of this act shall have and possess all the powers and jurisdiction conferred by this act, and may exercise the same within both the counties of Fillmore and Olmsted."

SEC. 2. This act shall take effect and be in force from and after its passage.

#### CHAPTER CCIV.

#### AN ACT TO LEGALIZE AND CONFIRM THE INCORPORATION OF THE RED WING HOTEL COMPANY.

#### Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That the incorporation of the Red Wing Hotel Company of Red Wing, Minnesota, be and the same is hereby legalized and made valid to all intents and purposes, notwithstanding any errors in the form of the articles of association thereof, or in the filing, execution or recording of said articles; and the organization of said association under said articles as adopted by them, and of record in the office of the register of deeds of Goodhue county, Minnesota, is hereby made valid and effectual, to the same extent as if the said articles of association had been duly executed, filed and recorded, as required by the statutes of this state.

SEC. 2. That all the acts and proceedings of the said Red Wing Hotel Company, or of the board of directors thereof, heretofore had or done under their said articles of association, and all conveyances to said association and all contracts and agreements by and with said association and any persons whomsoever heretofore made. done or entered into, are hereby legalized and made valid and effectual to all intents and purposes, and shall have the same force and effect, as if said association had been in all respects had in conformity to the provisions of the statutes of this state in such case made and provided.

SEC. 3. This act shall take effect and be in force from and after its passage.

## CHAPTER CCV.

### AN ACT TO RATIFY AND LEGALIZE THE INCORPORATION OF THE "MANKATO DRIVING PARK ASSOCIATION," AND FIX ITS LOCA-TION.

### Be it enacted by the Legislature of the State of Minnesota :

SECTION 1. The incorporation of the "Mankato Driving Park Association" in the county of Blue Earth, in this state, under articles for that purpose, filed and recorded in the office of the register of deeds in and for the county of Blue Earth, on the fifteenth day of September, 1873, and in the office of the secretary of the state of Minnesota, on the sixteenth day of said month and year, [is hereby declared to be legal and valid,] and the said Mankato Driving Park Association is hereby declared to be a legal and valid corporation, under title 3, chapter thirty-four of the general statutes of Minnesota, and all action had heretofore for the purpose of incorporating said association is hereby ratified and made valid to that end and no further. All acts done by said association since the filing and recording of articles, shall be taken and deemed to be valid, so far as the power of said association [to act as a corporation] is concerned, and the same are hereby legalized. The location of the Mankato Driving Park Association shall be deemed to be and shall be at the city of Mankato aforesaid.

SEC. 2. This act shall take effect and be in force from and after its passage.
