CHAPTER 107.

AN ACT TO REIMBURSE THE COUNTY OF CROW WING FOR THE EXPENSES OF THE TRIAL OF JUSTICE A. WILSON FOR MURDER.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. That the sum of one thousand (1000) dollars be, and the same is hereby appropriated, out of any money in the State treasury not otherwise appropriated, to reimburse the county of Crow Wing for the expenses of the trial of Justice A. Wilson for the murder of Patrick Egan.

Auditor to draw warrant. SEC. 2. That the State Auditor draw a warrant on the State Treasurer in favor of the county of Crow Wing for said amount and transmit the same to the Treasurer of Crow Wing county, who shall draw the money and place the same to the credit of the Crow Wing county reserve fund.

SEC. 3. This act shall take effect and be in force from and

after its passage.

CHAPTER 108.

AN ACT TO AUTHORIZE THE STATE TO PURCHASE A CERTAIN NUMBER OF COPIES OF COOLEY'S INDEX DIGEST OF THE TAX LAWS OF MINNESOTA FOR THE USE OF STATE, COUNTY AND TOWNSHIP OFFICERS.

Preamble.

Whereas, De Witt C. Cooley has written a complete Index Digest of the Tax Laws of Minnesota, to which is to be appended such laws in full with reference to the decisions of the Supreme Court thereon and all amendments thereof by the present Legislature; therefore,

Be it enacted by the Legislature of the State of Minnesota:

Section 1. That upon delivery by said Cooley to the Secretary of State of two thousand printed and covered copies of said Index Digest, with laws and amendments appended as aforesaid, he shall receive the same and deliver to said Cooley or his assigns a certificate of the delivery thereof. *Provided*, said books are in accordance with the foregoing preamble.

Anditor to draw warrant. SEC. 2. Upon the presentation of said certificate to the State Auditor he shall draw his warrant on the treasury of the State for the amount of the price of said books, allowing the same price therefor as the said book shall be sold for by said Cooley or his assigns to individuals, not exceeding one dollar per copy, and the State Treasurer shall pay the amount of said warrant out of any money in the treasury not otherwise appropriated.

SEC. 3. Said books shall be distributed in the same manner as copies of the Session Laws are required by law to be distributed, but only to the following named officers: One copy to each officer of the State, each member and officer of the tributed. Legislature, each Judge and Clerk of the Supreme and District Court, each Court Commissioner, each County Auditor, Treasurer, Sheriff, Register of Deeds, Town Clerk and each member of the State Board of Equalization.

Sec. 4. This act shall take effect and be in force from and

after its passage.

CHAPTER 109.

AN ACT TO CONFORM ALL SAVINGS BANKS OR INSTITU-TIONS FOR SAVINGS TO UNIFORMITY OF POWERS, RIGHTS , 105-109 AND LIABILITIES, AND TO PROVIDE FOR THE ORGANIZA-TIONS OF SAVINGS BANKS, FOR THEIR SUPERVISION, AND FOR THE MORE EFFICIENT PROTECTION OF DEPOSITORS IN SUCH INSTITUTIONS.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. All savings banks or institutions for savings now existing, or which may hereafter be organized under and by virtue of any law of this State, are hereby declared to be corporations possessed of the powers and functions of corporations generally, and as such shall have power:

declared to be

To have perpetual succession by its corporate name. To sue and be sued, complain and defend, in any court

of law or equity...

To make and use a common seal, which may be affixed by making an impression directly on the paper, and alter the General same at pleasure.

4. To appoint such officers, managers and agents as the

business of the corporation may require.

5. To make by-laws not inconsistent with the laws of this State, or of the United States, for the management of its property and the regulation of its affairs.

To contract and be contracted with.

To receive money on deposit, to invest the same, and further transact the business of a savings bank, as hereinafter provided,
