

investments for those named in this act, except as the same can be done gradually by the sale or redemption of the securities so invested in, in such manner as to prevent loss or embarrassment in the business of such corporation, or unnecessary loss or injury to the borrowers on such securities. And the investment hereafter in any such securities not named in this act, or the amendments that may be made thereto, shall be deemed a misdemeanor on part of the trustees authorizing or officers making the same, and such trustees or officers shall be subject to the prosecutions and punishments prescribed by law for that offense.

Evidence of  
deposit.

SEC. 50. All certificates or other evidences of deposit made in pursuance of the regulations and usages of any such corporation shall be as binding upon such corporation as though made under its common seal.

Misnomer not  
to impair any  
instrument.

SEC. 51. The misnomer of any such corporation in any deed, grant, contract, conveyance, or other instrument, shall not vitiate or impair the same, if the corporation be sufficiently described therein to ascertain the intention of parties.

SEC. 52. This act is hereby declared to be a public act and shall be construed favorably for every beneficial purpose therein contained, but no portion of this act shall apply to savings banks now in existence and operation in the State of Minnesota, which banks may be continued under the laws applicable to such banks before the passage of this act, unless they or any of them desire to organize thereunder.

SEC. 53. All acts and parts of acts inconsistent with the provisions of this act are hereby repealed, save so far as they may apply to the banks now organized.

SEC. 54. This act shall take effect and be in force from and after its passage.

## CHAPTER 110.

AN ACT TO APPROPRIATE MONEY FOR THE GENERAL EXPENSES OF THE STATE GOVERNMENT FOR THE YEAR ONE THOUSAND EIGHT HUNDRED AND SEVENTY-NINE (1879.)

*Be it enacted by the Legislature of the State of Minnesota:*

SECTION 1. That the following sums of money or so much thereof as may be necessary, be, and the same are hereby appropriated out of any moneys in the State Treasury belonging to the general revenue fund not otherwise appropriated, for the general expenses of the State Government for the year one thousand eight hundred and seventy-nine (1879.)

First—For executive contingent fund for State purposes and incidental expenses of the Governor's office, three thousand dollars (\$3,000). Contingent funds.

Second—For incidental expenses of secretary of state's office, three hundred dollars (\$300).

Third—For incidental expenses of the State auditor's office, five hundred dollars (\$500).

Fourth—For incidental expenses of State treasurer's office, two hundred dollars (\$200).

Fifth—For incidental expenses and per diem as allowed by law, of the attorney general, one thousand dollars (\$1,000).

Sixth—For incidental expenses of the adjutant general's office, two hundred and fifty dollars (\$250).

Seventh—For incidental expenses of the insurance commissioner's office, two hundred and fifty dollars (\$250).

Eighth—For incidental expenses and clerk hire of the public examiner, one thousand dollars (\$1,000).

Ninth—For incidental expenses of the railroad commissioner's office, two hundred dollars (\$200). *Provided*, This shall be in lieu of all clerk hire.

Tenth—For incidental expenses of the superintendent of public instruction, five hundred dollars (\$500).

Eleventh—For incidental expenses of the State library, three hundred dollars (\$300).

Twelfth—For incidental expenses of the supreme court, five hundred dollars (\$500).

Thirteenth—For the purchase of law books for the State library, one thousand dollars (\$1,000).

Fourteenth—For two hundred (200) copies of volume twenty-seven (27) of supreme court reports, twelve hundred dollars (\$1,200).

Fifteenth—For clerk hire for the Governor, twelve hundred dollars (\$1,200).

Sixteenth—For the purchase of paper for public printing, eight thousand dollars (\$8,000). Paper.

Seventeenth—For the purchase of stationery for the legislature and State officers, one thousand dollars (\$1,000).

Eighteenth—For the payment of costs in suits instituted by the attorney general on behalf of the State, three hundred dollars (\$300).

Nineteenth—For printing and binding, as provided by contract for the five (5) classes of printing and advertising for the various State officers and departments, twenty-two thousand dollars (\$22,000).

Twentieth—For preparing and indexing the general and special laws, two hundred dollars (\$200).

Twenty-first—For selecting, examining and selling State lands and making plats and appraising pine timber and detecting trespass upon State lands, five thousand dollars (\$5,000).

Twenty-second—For selecting and examining university lands, five hundred dollars (\$500).

**Sheriffs.**

Twenty-third—For payment of expenses of requisitions for absconding criminals, one thousand dollars (\$1,000), payable upon the order of the Governor.

Twenty-fourth—For the support of the Minnesota Historical Society, three thousand dollars (\$3,000).

Twenty-fifth—For expenses of the State Board of Health, one thousand five hundred dollars (\$1,500).

Twenty-sixth—For payment of mileage of county treasurers and express charges for the conveyance of State funds and bonds, one thousand dollars (\$1,000).

Twenty-seventh—For rent of arsenal, three hundred and fifty dollars (\$350).

Twenty-eighth—For repairs and furnishing the State capitol, three thousand dollars (\$3,000), to be expended under the direction of the Governor.

Twenty-ninth—For fuel and lights, water, ice etc., for the capitol, two thousand five hundred dollars (\$2,500).

Thirtieth—For rebinding books in the State library, one hundred dollars (\$100).

Thirty-first—For administering oaths to applicants for pensions in the adjutant general's office, seventy dollars and seventy-five cents (\$70.75).

Thirty-second—For purchasing of vault door and shelving in the secretary of state's room, two hundred and fifty-five dollars (\$255).

Thirty-third—For expenses of the State board of equalization, one thousand dollars (\$1,000).

Thirty-fourth—For extra clerk hire in State auditor's office, one thousand dollars (\$1,000).

Thirty-fifth—For payment of claims for arrests and conviction of horse thieves, four thousand dollars (\$4,000).

Thirty-sixth—For payment of claims for wolf bounties, five thousand dollars (\$5,000).

Thirty-seventh—For expenses of sheriffs, conveying convicts to State prison, three thousand five hundred dollars (\$3,500).

Thirty-eighth—For fees of registers and receivers of United States land offices for furnishing abstracts of entries of public lands for taxation as provided by section one hundred and eighteen (118) of general tax law, one thousand dollars (\$1,000).

Thirty-ninth—For publishing the general laws in newspapers, fifteen thousand dollars (\$15,000).

**Fish commissioners.**

Fortieth—For payment of expenses of hatching and distributing fish to be expended by the fish commissioners in accordance with the act providing for the culture and propagation of food fishes, five thousand dollars (\$5,000).

Forty-first—For payment of claims of persons who have complied with the act of one thousand eight hundred and seventy-three (1873), providing for a bounty for planting trees, three thousand five hundred dollars (\$3,500).

Forty-second—For payment of interest on temporary loans authorized by the legislature, two thousand dollars (\$2,000). Interest.

Forty-third—For payment of claim of Averill, Russell and Carpenter, fifty-six dollars and ten cents (\$56.10).

Forty-fourth—For payment of judges and clerks of election in election precincts in Kittson county in November one thousand eight hundred and seventy-eight (1878), thirty-seven dollars (\$37.00).

Forty-fifth—For payment to the city of Saint Paul one-half the cost of constructing a sewer along the capitol grounds on Tenth street, between Wabasha and Cedar streets, whenever said sewer is completed, five hundred dollars, (\$500).

Sec. 2. This act shall take effect and be in force from and after its passage.

## CHAPTER 111.

AN ACT TO APPROPRIATE MONEY FOR THE GENERAL EXPENSES OF THE STATE GOVERNMENT FOR THE YEAR ONE THOUSAND EIGHT HUNDRED AND EIGHTY (1880).

*Be it enacted by the Legislature of the State of Minnesota:*

SECTION 1. That the following sums of money or so much thereof as may be necessary, be and the same are hereby appropriated out of any moneys in the State treasury, belonging to the General Revenue Fund, not otherwise appropriated, for the general expenses of the State government for the year one thousand eight hundred and eighty (1880).

Fifth—For incidental expenses and per diem as allowed by law, of the Attorney General, one thousand dollars (\$1,000).

Sixth—For incidental expenses of the Adjutant General's office, two hundred and fifty dollars (\$250).
