CHAPTER 120.

AN ACT TO APPROPRIATE MONEY FOR FINISHING, HEATING AND FURNISHING THE MINNESOTA INSTITUTE BUILDINGS FOR THE DEAF AND DUMB AND BLIND.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That the sum of twenty-five thousand dollars (\$25,000) or so much thereof as may be necessary is hereby appropriated for the purpose of finishing, heating and furnishing the Minnesota institue building for the deaf and dumb and the blind. The same to be paid upon warrants drawn by the president and countersigned by the secretary of the board of directors of the institute, and that on presentation of such warrants to the State auditor, it shall be his duty to draw warrants on the State treasurer for like amounts, and such money shall be expended by direction of the board of directors of the said institute. *Provided*, That the warrants of the State auditor on the State treasurer for this appropriation shall not be drawn during the year 1879.

SEC. 2. This act shall take effect and be in force from and after its passage.

CHAPTER 121.

AN ACT TO APPROPRIATE MONEY FOR THE STATE UNIVERSITY.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That the following sums, or so much thereof as may be necessary, be and the same are hereby appropriated to the State University out of any moneys in the treasury not otherwise appropriated, to be expended for the following purposes, that is to say:

For furniture and apparatus for the University the sum of four thousand dollars (\$4,000.)

For enlarging the present grounds of the University, the sum of twenty thousand dollars (\$20,000.)

Warrants not to be drawn in 1879.

Furniture.

Grounds.

For a water supply for the University, the sum of three thousand five hundred dollars, the same to be paid on warrants to be drawn by the President and countersigned by the treasurer of the board of regents; and upon presentation of such warrants to the State Auditor, it shall be his duty to draw warrants on the State Treasurer for like amounts; such money to be expended under the direction of the board of regents of the University.

Provided, That not to exceed one-half of said first named sum, and no part of said second named sum shall be drawn from the treasury during the current year one thousand eight hundred and seventy nine (1879.)

SEC. 2. This act shall take effect and be in force from and after its passage.

CHAPTER 122.

AN ACT TO APPROPRIATE MONEY FOR THE SUPPORT OF THE SECOND MINNESOTA HOSPITAL FOR THE INSANE, LOCATED AT ROCHESTER.

Be it enacted by the Legislature of the State of Minnesota: .

SECTION 1. That the sum of twenty thousand dollars (\$20,000), or so much thereof as may be necessary be, and the Building purj same is hereby appropriated out of any money in the treasury poses. belonging to the State Institutions' Fund, and not otherwise appropriated, for general building purposes for the Second Minnesota Hospital for the Insane, located at Rochester, for the year one thousand eight hundred and eighty (1880).

That the further sum of two thousand five hundred dollars (\$2,500), or so much thereof as may be necessary, is hereby Barn. appropriated out of the same fund for the building of a barn and root cellar for the Second Minnesota Hospital for the Insane, located at Rochester, for the year one thousand eight hundred and seventy-nine (1879).

SEC. 2. This act shall take effect and be in force from and after its passage...
