

CHAPTER 7.

AN ACT TO AMEND SECTION FIFTY-EIGHT (58) OF TITLE SIX (6) OF CHAPTER TWENTY-EIGHT (28) STATUTES AT LARGE OF THE STATE OF MINNESOTA RELATING TO "BASTARDS AND THEIR SUPPORT."

Be it enacted by the Legislature of the State of Minnesota.

SECTION 1. That section fifty-eight (58), of title six (6), of chapter twenty-eight (28), Statutes at large of the State of Minnesota, be amended by adding to said section "*Provided*, that the court may upon the proof offered upon such application, discharge such prisoner, or make such proper order respecting any property, real or personal, the defendant may own or possess, having reference to the condition of the defendant and his family, if a married man, as the justice of the case may require in connection with such discharge.

SEC. 2. This act to take effect from and after its passage.

CHAPTER 8.

AN ACT TO AMEND CHAPTER ELEVEN (11) OF THE SESSION LAWS OF ONE THOUSAND EIGHT HUNDRED AND SEVENTY-THREE, (1873) RELATING TO MANUFACTURING CORPORATIONS.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That section three (3) of chapter eleven, (11) of the General Laws of this State for the year one thousand eight hundred and seventy-three, (1873) be and the same is hereby amended by adding at the end thereof the following proviso:

"*Provided*, That whenever, after the adoption, filing and publication of the articles of association, and the making and recording of the certificate provided for by this act, and the creation thereby of a body corporate, the said corporation shall resolve to alter, modify or change any of its articles of association, such corporation may, by resolution duly passed at any regular meeting of the stockholders thereof, adopt a new article or articles, altering, modifying or changing any of the original articles; *provided further*, that no such new or

amended articles shall change the general nature of its business, or be operative or valid to alter, modify or change such original articles until the same shall be published and the certificate of the purposes for which said corporation is formed as set forth in such new or amended articles, in the same manner and with the like formalities that the original articles are now required to be published and the certificate thereof recorded, and, when so adopted, published, and the certificate aforesaid recorded, the said amended articles shall be substituted for and take the place of the original articles so amended.

Concerning publication, etc

SEC. 2. This act shall take effect and be in force from and after its passage.

CHAPTER 9.

AN ACT TO AMEND SECTION ONE (1) OF CHAPTER ONE HUNDRED AND ONE (101) OF THE GENERAL STATUTES OF MINNESOTA (REVISION OF 1866) RELATING TO THE SALE OF UNWHOLESOME PROVISIONS.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That section one (1) of chapter one hundred and one (101) of the General Statutes of Minnesota (Revision of 1866) be amended so as to read as follows:

Section 1. Whoever knowingly sells any kind of diseased, corrupted or unwholesome provisions, whether for meat or drink, without making the same fully known to the buyer, or whoever having bought or come into the possession of any such diseased, corrupted or unwholesome provisions, shall offer or furnish the same or any part thereof as food or drink to any person or persons without first fully informing such person or persons to whom such provisions are offered, of the true condition of the same, shall be punished by imprisonment in the county jail not more than six months, or by fine not exceeding five hundred dollars (\$500), or by both such fine and imprisonment in the discretion of the court.

Sale of diseased meat forbidden.

Penalty.

SEC. 2. This act shall take effect and be in force from and after its passage.
