## CHAPTER XCIX.

AN ACT TO AMEND SECTION THIRTEEN OF CHAPTER ONE HUNDRED AND THIRTY-FOUR OF THE SPECIAL LAWS OF ONE THOUSAND EIGHT HUNDRED AND SIXTY-SEVEN, RELATING TO THE MISSISSIPPI AND RUM RIVER BOOM COMPANY.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. That section thirteen of chapter one hundred and thirty-four of the special laws of one thousand eight hundred and sixty-seven be and the same is hereby amended by adding at the

end thereof the following:

And provided further, that in case the said corporation shall desire to appropriate a lesser estate than fee simple or only an easement, then and in that case it shall acquire only such an estate or easement as may be defined in the petition for the appointment of commissioners; and the court may in its discretion in and by the order appointing such commissioners' limit the estate or easement to be acquired by said corporation by reserving to the land owner such rights and privileges therein to be defined in such order, as shall not be incompatible with the use for which the appropriation is made: such rights and privileges to be exercised and enjoyed in such manner as not to injure or interfere with the structures of said boom company or the free and legitimate use of such premises and structures for boom purposes.

Provided, that the provisions of this act shall not apply in any

action or proceeding heretofore commenced.

SEC. 2. This act shall take effect and be in force from and after its passage.

## CHAPTER C.

AN ACT TO AMEND AN ACT ENTITLED "AN ACT TO INCORPORATE THE VILLAGE OF GRAND MEADOW, MOWER COUNTY, MINNESOTA," APPROVED FEBRUARY TWENTY-FOUR, ONE THOUSAND EIGHT HUNDRED AND SEVENTY-SIX, AND THE ACTS AMENDATORY THEREOF.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. That section two of the charter of the village of Grand Meadow, Mower county, Minnesota, be, and the same is hereby, amended by adding to the end of said section the following, to wit:

"In addition to the officers enumerated above, there shall be elected one justice of the peace and one constable, who shall hold his office two years and until his successor is elected and qualified. said justice to have the same jurisdiction and to be governed by the same rules and regulations as township justices."

· Sec. 2. That section four of chapter forty-nine of the special laws of eighteen hundred and seventy-seven be, and the same is hereby, amended by inserting after the word "resignation" the words "or any other cause."

Sec. 3. All'acts or parts of acts inconsistent with this act, are

hereby repealed.

This act shall be in force and take effect from and after SEC. 4. its passage.

## CHAPTER CL

AN ACT TO AMEND SECTION THIRTEEN OF CHAPTER ONE HUN-DRED AND TWENTY-THREE, OF THE SPECIAL LAWS OF ONE THOUSAND EIGHT HUNDRED AND SEVENTY-SEVEN, RELATING. TO THE CITY OF SHAKOPEE.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. That section thirteen of chapter one hundred and twenty-three of special laws of the year A.D. one thousand eight hundred and seventy-seven, be amended so as to read as follows:

Sec. 13. When such assessment shall have been confirmed by the city council and the damages set apart, by said council for the payment of the same, it shall be a sufficient condemnation of the land or property ordered to be appropriated.

Sec. 2. All acts and parts of acts inconsistent herewith are

hereby repealed.
