CHAPTER CIV.

AN ACT TO DETACH CERTAIN TERRITORY FROM SCHOOL DISTRICT FIFTY-FOUR AND ATTACH THE SAME TO SCHOOL DISTRICT ELEVEN IN TOWN ONE HUNDRED AND SIX, RANGE ELEVEN, IN OLMSTED COUNTY.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That the south half of the northwest quarter and the south half of the northeast quarter of section thirty, town one hundred and six, range eleven in the county of Olmsted, be and the same is hereby detached from school district fifty-four and attached to school district number eleven of said county of Olmsted.

SEC. 2. This act shall take effect and be in force trom and after.

CHAPTER CV.

AN ACT TO CREATE A SCHOOL DISTRICT OUT OF CERTAIN TER-RITORY LYING IN THE TOWNS OF MONTGOMERY AND LANES-BURG, IN THE COUNTY OF LE SUEUR.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. That all of sections three, ten and sixteen, and the west half of sections two, eleven and fifteen, and the east half of sections four and nine in township number one hundred and eleven, north of range twenty-three west, and the east half of section thirty-three, and the west half of section thirty-four, in township one hundred and twelve, north of range twenty-three west, all being in the county of Le Sueur be, and the same and any part of the foregoing territory is hereby, set off and created into and declared to be a special school district under the name and style of "the Montgomery school district," and as such school district under the name and style aforesaid, to have and enjoy all the powers and rights, and be subject to all the duties of a common school district, organized under the general laws of this state.

Sec. 2. The legal voters within said school district, within sixty days after the passage of this act, shall meet at L nlas' hall, in the village of Montgomery, in said county, or any other place within said school district designated in the notice of such meeting, and elect a director, treasurer and clerk of said district, and the officers so elected shall immediately qualify, and the clerk shall thereupon and at once notify the proper officers of said county of Le Sueur, of

said election, provided, a notice of the time and place of said meeting, signed by any five of the legal voters residing within said school district, shall be given in the manner prescribed by law.

SEC. 3. Whenever any officers are elected or taxes are voted by said district, the clerk thereof shall report the same to the proper officers of said county of Le Sueur, and such taxes shall be levied upon the property and collected by the proper officers of said county in the same manner as other taxes are levied and collected, and the same, together with all other moneys due said district, shall be paid over to the treasurer of said district, and all taxes now levied upon any of the property, real or personal, now embraced in said Montgomery school district, shall, when collected, be paid to said treasurer of Montgomery school district.

SEC. 4. The county superintendent of the county of Le Sueur, shall have jurisdiction over said district, and visit the same, and grant certificates to teach therein as in other cases, or school dis-

tricts within said county of Le Sueur.

Sec. 5. This act shall take effect and be in force from and after

its passage.

CHAPTER CVI.

AN ACT TO ESTABLISH A NEW SCHOOL DISTRICT IN THE COUNTY OF McLEOD.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. That out of that portion of joint school district number sixteen, which lies in McLeod county, (the said district embracing territory in both Sibley and McLeod counties) there is hereby created and established a new school district which shall comprise sections nineteen, twenty, twenty-one, twenty-eight, twenty-nine, thirty, thirty-one, thirty-two and thirty-three of township one hundred and fourteen north, of range twenty-nine west, situate in McLeod county, aforesaid, and forming the southwest quarter of said township.

SEC. 2. It shall be the duty of the county commissioners of said county of McLeod to properly number the school district hereby established, and to take such action as will give practical

effect to this act and facilitate its purpose.

SEC. 3. All acts and parts of acts inconsistent with this act are

hereby repealed.

SEC. 4. This act shall take effect and be in force from and after its passage.
