

CHAPTER CXXIV.

AN ACT TO DETACH CERTAIN TERRITORY FROM SCHOOL DISTRICT NUMBER TWENTY-FOUR, IN McLEOD COUNTY, AND ATTACH THE SAME TO SCHOOL DISTRICT NUMBER FORTY, OF McLEOD COUNTY.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That the south half of section nineteen, and the southwest quarter of section twenty in township one hundred and sixteen range twenty-nine west, be and the same is hereby detached from school district number twenty-four, in McLeod county, and attached to school district number forty, in said county.

SEC. 2. This act shall take effect and be in force from and after its passage.

CHAPTER CXXV.

AN ACT TO VACATE SCHOOL DISTRICT NUMBER TWENTY-FOUR IN McLEOD COUNTY, MINNESOTA, AND ATTACH THE SAME TO INDEPENDENT SCHOOL DISTRICT NUMBER TWO, IN SAID COUNTY.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That school district number twenty-four, in McLeod county, consisting of the following territory, to wit: Section sixteen, seventeen, east half of southwest quarter of section eighteen, north half of section nineteen, north half and the north half of southeast quarter of section twenty, north half of section twenty-one of township one hundred and sixteen, range twenty-nine, and northeast quarter of section twenty-four of township one hundred and sixteen, range thirty, is hereby as a body corporate, vacated and abolished, and the territory included within the limits of said school district number twenty-four, shall hereafter constitute and be a part of independent school district number two in McLeod county, for all purposes whatsoever.

SEC. 2. That all books, records and papers now in the office of district clerk of said school district twenty-four, shall be, on or before the tenth day of March, one thousand eight hundred and seventy-nine, transferred and delivered by the clerk of said school district twenty-four, to the clerk of said independent school district number two; and all books, records, papers and moneys, belonging to said school district number twenty-four, now in the office of the treasurer of said school district twenty-four, shall be on or before the tenth day of March, one thousand eight hundred and seventy-nine, transferred and delivered by the treasurer of school district number twenty-four to the treasurer of independent school district number two, aforesaid.

SEC. 3. This act shall take effect and be in force from and after its passage.

CHAPTER CXXVI.

AN ACT TO ESTABLISH AND ORGANIZE AN INDEPENDENT SCHOOL DISTRICT IN MORRISON COUNTY.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That all that part of Morrison county hereinafter described, shall be, and is hereby organized and made to be an independent school district in Morrison county, to be known as the independent school district of Little Falls, viz.: All the sections from seven to eighteen inclusive of both the township forty north, range thirty-two, west of the fourth principal meridian. All of sections thirty-four, thirty-five and thirty-six, in township forty-one north, of range thirty-two, west of the fourth principal meridian, and all of section seventeen; the east half of section eighteen, the east half, and lots four and five, in section nineteen, and all of section thirty in township one hundred and twenty-nine, north of range twenty-nine, west of the aforesaid meridian. That on and after Thursday, the third day of April, one thousand eight hundred and seventy-nine, the above described territory shall constitute in law one separate and independent school district.

SEC. 2. That the legally qualified voters residing within the said school district on the said third day of April, A. D. one thousand eight hundred and seventy-nine, hold an election for the purpose of electing six persons residents of said district, who shall be legal voters therein, to be and constitute the board of education within and for said district.
