## CHAPTER CXXIX.

AN ACT TO ALTER THE BOUNDARIES OF CERTAIN SCHOOL DISTRICTS IN FILLMORE COUNTY, MINNESOTA, AND TO ADD TO SCHOOL DISTRICTS NUMBERS FORTY-EIGHT AND FIFTY-THREE IN SAID COUNTY.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. The boundaries of school districts numbers fifty-two, fifty-three and forty-eight, in Fillmore county, Minnesota, are altered as follows: The south half of section number sixteen and all of section number twenty-one are added to school district number fifty-three, and the south half of section thirty-three and the southwest quarter and west half of the southeast quarter of section number thirty-four are detached from district number fifty-three and added to school district number torty-eight.

SEC. 2. All acts and parts of acts inconsistent with this act are

hereby repealed.

SEC. 3. This act shall take effect and be in force from and after its passage.

## CHAPTER CXXX.

AN ACT TO ESTABLISH THE INDEPENDENT SCHOOL DISTRICT OF GRANITE FALLS.

. Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That all that part of union school district number twenty one, in the counties of Chippewa and Yellow Medicine which lies west of the Minnesota river, in Yellow Medicine county, is hereby detached from said district, and set apart and established as an independent school district, and shall be a body corporate under the name of "Independent school district of Granite Falls."

SEC. 2. At any time after this act shall take effect, written notices shall be posted in three of the most public places in said district, signed by at least six resident freeholders of the same, requesting the qualified electors of said district to assemble upon a specified day, at some suitable place in said district, to be named in said notices; which notices shall be so posted at least ten days next prior to said meeting then and there to choose by ballot six directors of the public schools of said district, and such directors when so elected pursuant to such notice, shall serve as follows: two of them for one year from the first Saturday in September, eighteen hundred and seventy-nine; two of them for two years from said date, and two of them for three years from said date; the time that each shall serve to be designated on the ballot. And annually thereafter, beginning on the first Saturday in September of the year eighteen hundred and eighty, there shall be chosen in the same manner two directors, each of whom shall serve for three years, and until their successors are elected and qualified.

SEC. 3. All the provisions of chapter seventy-four of the general laws of the year eighteen hundred and seventy-seven, not inconsistent herewith, and applicable to independent school districts, shall be applied to and govern the district hereby established, and the

officers of the same.

Sec. 4. This act shall take effect and be in force from and after the first day of July, eighteen hundred and seventy-nine.

## CHAPTER CXXXI.

AN ACT TO ESTABLISH A SCHOOL DISTRICT IN THE COUNTY OF CASS, AND TO INCORPORATE THE SAME.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. That all the territory included in, and constituting township number one hundred and thirty-three north, range number twenty-eight, and township number one hundred and thirty-four north, range number twenty-eight west, in the county of Cass, in the state of Minnesota, be, and the said territory is hereby set off, established and incorporated as a special school district, under the corporate name of "The West Brainerd School District."

Sec. 2. The said West Brainerd school district shall forever

Sec. 2. The said West Brainerd school district shall forever possess and enjoy all the powers, rights and privileges, and be subject to all the duties of any school district corporation established or organized under the general laws of the state of Minnesota.
