

SEC. 2. At any time after this act shall take effect, written notices shall be posted in three of the most public places in said district, signed by at least six resident freeholders of the same, requesting the qualified electors of said district to assemble upon a specified day, at some suitable place in said district, to be named in said notices; which notices shall be so posted at least ten days next prior to said meeting then and there to choose by ballot six directors of the public schools of said district, and such directors when so elected pursuant to such notice, shall serve as follows: two of them for one year from the first Saturday in September, eighteen hundred and seventy-nine; two of them for two years from said date, and two of them for three years from said date; the time that each shall serve to be designated on the ballot. And annually thereafter, beginning on the first Saturday in September of the year eighteen hundred and eighty, there shall be chosen in the same manner two directors, each of whom shall serve for three years, and until their successors are elected and qualified.

SEC. 3. All the provisions of chapter seventy-four of the general laws of the year eighteen hundred and seventy-seven, not inconsistent herewith, and applicable to independent school districts, shall be applied to and govern the district hereby established, and the officers of the same.

SEC. 4. This act shall take effect and be in force from and after the first day of July, eighteen hundred and seventy-nine.

CHAPTER CXXXI.

AN ACT TO ESTABLISH A SCHOOL DISTRICT IN THE COUNTY OF CASS, AND TO INCORPORATE THE SAME.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That all the territory included in, and constituting township number one hundred and thirty-three north, range number twenty-eight, and township number one hundred and thirty-four north, range number twenty-eight west, in the county of Cass, in the state of Minnesota, be, and the said territory is hereby set off, established and incorporated as a special school district, under the corporate name of "The West Brainerd School District."

SEC. 2. The said West Brainerd school district shall forever possess and enjoy all the powers, rights and privileges, and be subject to all the duties of any school district corporation established or organized under the general laws of the state of Minnesota.

SEC. 3. The legal voters residing within said school district shall, within ninety days after the passage of this act, meet in said district and elect a director, treasurer and clerk of said district, and forthwith thereupon the said clerk shall report said election, to the proper county officers. *Provided*, That a notice of the time and place of said meeting, signed by any five of said legal voters, shall be given in the manner prescribed by law.

SEC. 4. This act shall take effect and be in force from and after its passage.

CHAPTER CXXXII.

AN ACT TO DETACH CERTAIN TERRITORY FROM SCHOOL DISTRICT NUMBER THREE, IN TOWN OF OTTAWA, IN LE SUEUR COUNTY, AND TO ATTACH THE SAME TO INDEPENDENT SCHOOL DISTRICT NUMBER TWELVE IN SAME TOWN AND COUNTY.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That the northwest quarter of section number twenty-six and the northeast quarter of section number twenty-seven, in town one hundred and eleven north, of range twenty-six west, be and the same is hereby detached from school district number three in the town of Ottawa, in the county of Le Sueur and state of Minnesota, and the said territory is hereby attached to independent school district number twelve, in said town of Ottawa.

SEC. 2. This act shall take effect and be in force from and after its passage.

CHAPTER CXXXIII.

AN ACT TO AUTHORIZE THE BOARD OF COUNTY COMMISSIONERS OF SWIFT COUNTY TO ISSUE BONDS TO FUND THE PRESENT FLOATING INDEBTEDNESS OF SAID COUNTY.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. The board of county commissioners for the county of Swift, state of Minnesota, is hereby authorized at any time prior to the first day of January, A. D. one thousand eight hundred and eighty, to issue and negotiate the bonds of said county (with cou-
