CHAPTER CLXXXIX.

AN ACT TO AUTHORIZE THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF HENNEPIN TO PAY THE CLAIM OF JOSEPH E. LYONS FOR SERVICES RENDERED IN MAKING STENOGRAPHIC REPORT OF THE EVIDENCE TAKEN BEFORE THE CORONER'S JURY EMPANNELED IN THE MATTER OF THE FIRE AND EXPLOSION IN THE MINNEAPOLIS MILLS, MAY SECOND, EIGHTEEN HUNDRED AND SEVENTY-EIGHT.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. That the county commissioners of the county of Hennepin be, and they are hereby authorized to pay to Joseph E. Lyons, out of any money in the treasury of the county not otherwise appropriated, such sum as may be a just compensation not exceeding the sum of two hundred dollars, with interest upon the same from the first day of June, 1878, until paid; the said sum to be in full satisfaction of and payment for the services rendered by said Joseph E. Lyons, in making stenographic report of the evidence taken before the coroner's jury empanneled to investigate the cause of the death of those persons who perished in the fire and explosion in the Minneapolis mills on the second day of May, eighteen hundred and seventy-eight.

SEC. 2. This act shall take effect and be in force from and after

its passage.

CHAPTER CXC.

AN ACT TO AUTHORIZE THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF HENNEPIN TO PAY CERTAIN CLAIMS FOR THE PUBLICATION OF THE OFFICIAL PROCEEDINGS OF SAID BOARD.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. That the county commissioners of the county of Hennepin be and they are hereby authorized to pay to Edward A. Stevens and the Minneapolis Tribune Company, out of any money in the treasury of the county not otherwise appropriated, such sum as may be a just compensation, not exceeding the sum of two hun-

dred dollars; said payments to be in full satisfaction of and payment for the publication of certain official proceedings of said board, and for other publications made by order of said board, during the months of November and December, one thousand eight hundred and seventy-eight, and the months of January and February one thousand eight hundred and sevnety-nine.

This act shall take effect and be in force from and after

its passage.

CHAPTER CXCI.

AN ACT TO AUTHORIZE THE TOWN SUPERVISORS OF THE TOWN OF MINNEAPOLIS AND MINNETONKA IN THE COUNTY OF HEN-NEPIN TO OPEN AND EAY OUT A CERTAIN TOWN LINE ROAD BETWEEN SAID TOWNS.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. That town supervisors of the towns of Minneapolis and Minnetonka are hereby authorized and empowered to lay out and open a town line road on the line between the town of Minneapolis and the towns of Minnetonka and Plymouth, from the highway running across said town line in easterly and westerly direction, near the southwest corner of the southwest quarter of section seven, in township one hundred and seventeen north, of range twenty-one west, commonly called Minnetonka road, to the highway running in an easterly and westerly direction across said town line near the northwest corner of the southwest quarter of section thirty-one in township one hundred and eighteen, range twentyone, commonly called the Watertown road, subject however to all other provisions of the laws of Minnesota regarding the opening and laying out of town line roads, except that said road may be laid out upon the petition of a majority of all the legal voters of either of said towns living within one mile of the road authorized to be laid out under the provisions of this act.

Sec. 2. This act shall take effect and be in force from and after

its passage.
