CHAPTER CCXXIX.

AN ACT TO LEGALIZE THE ORGANIZATION OF CERTAIN SCHOOL DISTRICTS IN BLUE EARTH COUNTY, AND TO LEGALIZE THE OFFICIAL ACTS OF THE TRUSTEES OF SAID SCHOOL DISTRICTS.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. That school districts numbered thirty-eight, thirty-nine, forty, forty-one, one hundred and thirty-six, and one hundred and thirty-seven, in the county of Blue Earth, as the same are now constituted, are hereby declared to be organized school districts within said county, having all the rights, privileges and immunities of other organized school districts therein, and all proceedings had in organizing said school districts, and all the official acts of the trustees of said school districts, are hereby legalized and declared to be valid.

SEC. 2. This act shall take effect and be in force from and after

its passage.

CHAPTER CCXXX.

AN ACT TO LEGALIZE CERTAIN ROADS AND HIGHWAYS IN THE COUNTY OF POPE.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. That all roads or highways laid out and opened prior to the year A. D. one thousand eight hundred and seventynine, in the county of l'ope and the state of Minnesota by the commissioners of said county or the supervisors of any town in said county are hereby declared to be public roads or highways and confirmed and established as such whether the same have been lawfully laid out, established and opened or not, provided that public work or public money has been expended upon any such road or roads or any part thereof.

SEC. 2. Any person having an unsettled claim for damages against said county or any town in said county by reason of the laying out and opening of said roads or any of them, shall at any regular meeting before the regular meeting of the commissioners of said county or the supervisors of any town in said county in the month of July, A. D. one thousand eight hundred and eighty present such claim in writing to the auditor of said county or the clerk of such town who shall lay the same before said commissioners or supervisors, as the case may be, for their action thereon, and if any person having such claim shall fail to present it as aforesaid, he shall forever be debarred from further redress for said damages.

Provided, That nothing in this act shall be so construed as to revive any right or claim for damages now barred by law or the statutes of limitations, and provided further that any party may appeal from the decision of such supervisors or commissioners as is now provided by law for appeals from awards or damages in lay-

ing out county or town roads.

SEC. 3. This act shall take effect and be in force from and after

its passage.

CHAPTER CCXXXI.

AN ACT TO LEGALIZE CERTAIN ROADS AND HIGHWAYS IN THE COUNTY OF DOUGLAS.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. That all roads and highways laid out and opened prior to the year A. D. eighteen hundred and seventy-nine, in the county of Douglas and state of Minnesota, by the commissioners of said county or the supervisors of any town in said county, are hereby declared to be public roads or highways, and confirmed and established as such, whether the same have been lawfully laid out, established and opened or not, provided that public work or public money has been expended upon such road or roads, or any part thereof.

SEC. 2. Any person having an unsettled claim for damages against said county or any town therein, by reason of the laying out and opening of said roads or any of them, shall at any regular meeting prior to the regular meeting of the commissioners of said county or the supervisors of any town therein, in the month of July, A. D. eighteen hundred and eighty, present such claim in writing to the auditor of said county or the clerk of such town,
