

CHAPTER CCLXXXV.

AN ACT TO CHANGE THE NAME OF WILLIAM ULYSSES WILLEY TO
ROBERT LOUIS KELLEY.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That the name of William Ulysses Willey, of the county of Hennepin, be, and the same hereby is changed to Robert Louis Kelley.

SEC. 2. This act shall take effect from and after its passage.

CHAPTER CCLXXXVI.

AN ACT TO CHANGE THE NAME OF THE TOWN OF SLEEPY EYE
LAKE, IN BROWN COUNTY, IN THE STATE OF MINNESOTA, TO
LORENA, AND LEGALIZE CERTAIN COMMISSIONERS THEREIN.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That the name of the town of Sleepy Eye Lake, in the township of Home, in the county of Brown, and State of Minnesota be, and the same is hereby, changed to that of Lorena, by which name it shall hereafter be known, and in all transfers of real estate within the limits of said village, or within the limits of Brackenridge's addition to the said town of Sleepy Eye Lake, made and acknowledged after the passage of this act, the same shall be described as being in the village of Lorena, and shall be as effectual to convey the title to such property, as though the name of said town had never been changed, and no rights, privileges or immunities whatever, shall be affected by such change of name.

SEC. 2. All conveyances of real estate within the limits of the surveyed plat of said town as surveyed and platted by T. G. Carter, in the year A. D. one thousand eight hundred and seventy-two, and all conveyances of real estate within the limits of the surveyed plat of Brackenridge's addition to said town, as surveyed and platted by T. G. Carter, in the year A. D. one thousand eight hundred and seventy-three, heretofore made and executed, or that may be made and executed before the first day of next April, and heretofore or here-

after duly recorded in the proper records of said county, are hereby declared legal and sufficient to convey all the rights, title and interest the grantor or grantors had or may have at the time of such conveyance in and to the property intended to be conveyed according to the intent and meaning of the instrument, whether the same is described as being in the town or village of Sleepy Eye Lake, or in Brackenridge's addition to said town, or in the town of Lorena.

SEC. 3. This act shall take effect and be in force from and after its passage.

CHAPTER CCLXXXVII.

AN ACT TO CHANGE THE NAME OF THE TOWN OF EDDISON IN THE COUNTY OF SWIFT TO THAT OF NEW POSEN.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That the name of the township of Eddison, in the county of Swift, be, and the same is hereby changed to that of New Posen.

SEC. 2. This act shall take effect and be in force from and after its passage.

CHAPTER CCLXXXVIII.

AN ACT TO CHANGE THE NAME OF THE TOWNSHIP OF KALMIA, IN THE COUNTY OF CHIPPEWA, TO THAT OF MANDT.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That the name of the township of Kalmia, in the county of Chippewa, be, and the same is hereby changed to that of Mandt.

SEC. 2. This act shall take effect and be in force from and after its passage.
