

CHAPTER CCXCV.

AN ACT TO CHANGE THE NAMES OF CERTAIN PERSONS THEREIN
NAMED.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That the name of Charles H. Ljungquist, of the county of Isanti, is hereby changed to Charles H. Youngquist.

SEC. 2. The name of Peter Shureson, of the county of Fillmore, is hereby changed to P. S. Wangssnes.

SEC. 3. The name of Lewis Peterson, of the county of Fillmore, is hereby changed to L. P. Helmey.

SEC. 4. The name of Louis Oliver Lyons, of the county of Douglas, is hereby changed to Louis Oliver Hammond.

SEC. 5. The name of Ole Stengrimson, of the county of Waseca, is hereby changed to Ole S. Holand.

SEC. 6. The name of Margaretha Webb, of the county of Blue Earth, is hereby changed to Margaretha Hodapp.

SEC. 7. The name of Ole J. Johnson, of the county of Goodhue, is hereby changed to Ole J. Lebakken.

SEC. 40. This act shall be in force and take effect from and after its passage.
