some point between St. Peter and the mouth of Redwood river. being the same branch road mentioned and referred to in Section two of Chapter three, of the special laws of the year one thousand eight hundred and sixty-five, approved February eleventh, one thousand eight hundred and sixty-five, be and the same is hereby extended until the twenty-fifth day of December, one thousand eight hundred and eighty-five, and all the rights, privileges, franchises and immunities heretofore granted to the Minneapolis and St. Cloud Railroad Company are hereby continued and extended until the said twenty-fifth day of December, A. D. one thousand eight hundred and eighty-five. And if the said branch road shall at the date last aforesaid be fully completed and equipped, then and in such case the said rights, privileges, franchises and immunities shall continue and be perpetual, as is in and by the original act of incorporation of said railway company and the acts amendatory thereof provided.

SEC. 2. This act shall not take effect or be in force until a consolidation shall have been perfected in the manner prescribed in chapter four of the special laws of the year one thousand eight hundred and sixty-five, approved February twenty-eighth, one thousand eight hundred and sixty-five, of the capital stock representing and controlling the said branch road, with the capital stock of the Mankato and St. Cloud Railroad Company, now organized or being organized as a corporation under General Statutes of this state by articles of incorporation, bearing date on the 20th day of February, A. D. one thousand eight hundred and seventy nine; and from and after such consolidation this act shall take effect and be in force.

CHAPTER CCCXXVI.

AN ACT TO EXTEND THE CORPORATE LIMITS OF THE VILLAGE OF NEW RICHLAND.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That the corporate limits of the village of New Richland, in the county of Waseca, state of Minnesota be, and the same are hereby extended so as to include all that territory and land in the county of Waseca, situate and described as follows, to wit:

Three acres in the northeast corner of the southeast quarter of the southwest quarter of section seventeen, town one hundred and five, range twenty-two west, three hundred and forty-five feet east, and west by three hundred and seventy-eight and eighteen twentythirds feet north and south, and two acres in the southeast corner of the northeast quarter of the southwest quarter of section seventeen, town one hundred and five, range twenty-two west, three hundred and forty-five feet east and west, by two hundred and fifty-two and twelve and twenty-thirds north and south.

SEC. 2. The territory hereby added to the said village of New Richland, and all persons residing or being thereon shall hereafter be subject to the jurisdiction, law or ordinances now or hereafter in

force in said village.

SEC. 3. This act shall have effect and be in force from and after

its passage.

CHAPTER CCCXXVII.

AN ACT TO EXTEND THE INCORPORATED LIMITS OF THE VILLAGE OF FAIRMONT, IN MARTIN COUNTY.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That all that portion of the village plat of the village of Fairmont, Martin county, and all the land lying and being west of the now incorporated part of said village, and east of the lakes and outlet immediately west of said village corporation, be and the same is hereby annexed to and made a part of the incorporated village of Fairmont aforesaid.

SEC. 2. The territory hereby added to the said corporation of the village of Fairmont shall hereafter be subject to the jurisdiction, laws and ordinances now or hereafter in force in said village, in like manner as the territory heretofore embraced in the corporate limits

of said village.

Sec. 3. This act shall take effect and be in force from and after its passage.
