

CHAPTER CCCXXVIII.

AN ACT TO PROVIDE FOR THE LEVY AND COLLECTION OF POLL ROAD TAXES IN THE CITY OF DULUTH IN THE COUNTY OF ST. LOUIS, IN CASE SAID CITY SHALL NEGLECT TO LEVY ROAD TAXES, OR TO APPOINT AN OVERSEER OF HIGHWAYS TO COLLECT SUCH TAXES.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. Whenever, for any reason, there is a failure to appoint an overseer of highways in the city of Duluth in the county of St. Louis, as provided in chapter five of the general laws of one thousand eight hundred and seventy-three, the board of county commissioners of said county are authorized to appoint a suitable person resident in said city to act as such overseer of highways therein.

SEC. 2. That the overseer of highways appointed by the commissioners of St. Louis county aforesaid, as provided in section one of this act, shall have all of the powers and privileges and shall be chargeable with all of the duties and liabilities of an overseer of the highways appointed under the provisions of chapter five of the general laws of one thousand eight hundred and seventy-three aforesaid, and shall within sixteen days after his appointment make and deliver to the county auditor of said county a list, subscribed by said overseer, of all the inhabitants of the said city who are liable to work on highways.

SEC. 3. Upon receiving such list the said board of county commissioners of said county shall, at their next general or special meeting, levy upon the inhabitants of said city as shown by the list filed by the overseer of highways as aforesaid, a poll road tax as provided in section nine of said chapter five of the general laws of one thousand eight hundred and seventy-three, and said tax shall be enforced in the same manner and with the same effect, and shall be as valid in all respects as poll road taxes assessed by the terms and provisions of said chapter five of the general laws of one thousand eight hundred and seventy-three.

SEC. 4. Any person or persons in said city, against whom a poll road tax has been assessed as aforesaid, and who has been duly notified as provided by said general laws, and who does not commute, and who refuses or neglects to appear as provided in said general law, shall be fined as provided in said chapter five of the general laws of one thousand eight hundred and seventy-three, upon complaint of said overseer of highways made before any justice of the peace of said county of St. Louis.

SEC. 5. That the proceedings of such justice of the peace upon said complaint shall conform to and be the same in all respects as is provided for in sections twenty, twenty-one, twenty-two and twenty-three of said chapter five of the general laws of one thousand eight hundred and seventy-three as fully as if the same had been incorporated herein.

SEC. 6. Such overseer of highways so appointed as hereinbefore provided shall hold his office for the term of one year and until his successor is appointed and qualified.

SEC. 7. This act shall take effect and be in force from and after its passage.

CHAPTER CCCXXIX.

AN ACT TO PROVIDE FOR THE ELECTION OF A SUPERINTENDENT OF PUBLIC SCHOOLS IN DODGE COUNTY.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. The electors of the county of Dodge, in this State, are hereby authorized and empowered to vote at the general election to be held in said county in the year 1879, for a county superintendent of public schools of said county, who shall hold the office during the remainder of the current term and until his successor is qualified according to law; and the superintendent so elected shall, immediately after the votes are canvassed, qualify in the manner now provided by law, and enter upon the discharge of his duties.

SEC. 2. This act shall take effect and be in force from and after its passage.
