

CHAPTER CCCXXXIII.

AN ACT PROVIDING FOR THE ENLARGEMENT OF THE COUNTY SEAT OF MOWER COUNTY.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That the county seat of the county of Mower be and the same is hereby enlarged so as to include all the territory included in the corporate limits of the city of Austin.

SEC. 2. This act shall take effect and be in force from and after its passage.

CHAPTER CCCXXXIV.

AN ACT TO PROVIDE FOR THE LOCATION OF CERTAIN ROADS IN THE COUNTY OF HENNEPIN.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. The county commissioners of the county of Hennepin are hereby authorized and required, as soon as may be after the passage of this act to survey, locate and establish a public highway in said Hennepin county, one hundred feet in width commencing at the point on the easterly boundary line of said county, where the section line between sections nineteen and thirty, township twenty-nine, range twenty-three, intersects said county line, and running thence west on said section line to the easterly boundary line of the city of Minneapolis, also a highway eighty feet in width, commencing on the easterly boundary line of said Hennepin county, at or near the point where the section line between sections seven and eighteen, township twenty-nine, range twenty-three, intersects said county line, and running thence southwesterly, following as near as practicable, a line in the direction of the stone arch bridge in the city of Minneapolis, to the easterly boundary line of said city. And

the said commissioners shall assess all damages accruing to any and all persons by the appropriation of lands in the laying out of said highways.

SEC. 2. The said commissioners may proceed at any regular or special meeting thereof hereafter held to discharge the duties imposed upon them by this act, and on so doing shall be governed by the provisions of law relating to the laying out and establishing of county roads in cases of petitions duly presented to them. This act to take the place of and stand in lieu of such petitions.

SEC. 3. This act shall take effect and be in force from and after its passage.

CHAPTER CCCXXXV.

AN ACT TO PREVENT THE RUNNING AT LARGE OF CATTLE OR OTHER DOMESTIC ANIMALS IN THE COUNTY OF MOWER.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That section two of chapter one hundred and seventy-one, special laws of eighteen hundred and seventy-six, be and the same is hereby amended so as to read as follows, to-wit:

SEC. 2. Any person or persons who shall violate or neglect the provisions of the first section of the general laws of eighteen hundred and seventy five, chapter one hundred and twenty-four, shall be liable for all damages that may ensue in consequence of the trespass of such animal or animals.

SEC. 3. This act shall take effect and be in force from and after its passage.
