CHAPTER 137.

AN ACT ENTITLED AN ACT PROVIDING FOR [THE] TERMS OF THE DISTRICT COURT FOR OTTER TAIL COUNTY IN THE STATE OF MINNESOTA.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That terms of the district court in Otter Tail county, state of Minnesota, shall be held as follows: On the third (3d) Monday of May and the second (2d) Monday of November in each year.

Time of holding general terms of court.

SEC. 2. All acts and parts of acts inconsistent herewith are hereby repealed.

Repeal of inconsistent acts.

SEC. 3. This act shall take effect and be in force from and after April first (1st), A. D. one thousand eight hundred and eighty-five (1885.)

When act to take effect.

Approved March 5, 1885.

CHAPTER 138.

AN ACT FIXING THE TIMES FOR HOLDING THE GENERAL TERMS OF THE DISTRICT COURT IN THE ELEVENTH (11TH) JUDICIAL DISTRICT.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. The general terms of the district court in and for the eleventh (11th) judicial district of this state shall be held as follows:

Time of holding general terms of court.

In the county of Aitkin, on the fourth (4th) Monday in September in each year.

In the county of Wadena, on the first (1st) Monday after the twenty-eighth (28th) day of May, and on the fourth (4th) Monday in November in each year.

In the county of Carleton, on the first (1st) Monday in April and the first (1st) Monday in October in each year.

In the county of Clay, on the first (1st) Monday after the first (1st) day of January and on the first (1st) Monday after the fourth (4th) day of July in each year.

In the county of Crow Wing, on the second (2d) Monday in March and on the second (2d) Monday in September in each year.

In the county of Kittson on the fourth (4th) Monday in March in each year.

In the county of Marshall, on the last Monday but one (1) in May and on the third (3d) Monday in November in each year.

In the county of Becker, on the first (1st) Monday after the eleventh (11th) day of June and on the second (2d) Monday after the twenty-eighth (28th) day of November in each year.

In the county of Polk, on the first (1st) Monday in June and on the first (1st) Monday in December in each year.

In the county of St. Louis, on the first (1st) Monday after the first (1st) day of January and on the last Monday in April and on the first (1st) Monday in September in each year.

In the county of Norman, on the third (3d) Monday in May and on the second (2d) Monday in November in each year.

Recognizances,
etc., deemed
returnable to
said terms of
court.

SEC. 2. All writs, processes, bonds, recognizances, continuances, appeals, notices, and proceedings had, issued or returnable to the terms of court in and for each of said counties, as fixed by law prior to the passage of this act, shall be deemed and construed as made, taken and returnable to the terms of court in each of said counties fixed by this act.

Repeal of incon-
sistent acts.

SEC. 3. Chapter eighty-two (82) of the general laws of Minnesota for A. D. one thousand eight hundred and eighty-one (1881), regular session, and all acts and parts of acts inconsistent with this act are hereby repealed.

When act to
take effect.

SEC. 4. This act shall take effect and be in force from and after its passage.
