CHAPTER 15.

AN ACT AMENDING SECTION ONE HUNDRED AND TWO (102) OF CHAPTER ELEVEN (11) OF THE GENERAL STATUTES, RELATING TO THE SALE OF PROPERTY FORFEITED TO THE STATE.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. That section one hundred and two (102) of chapter eleven (11) of the general statutes be amended, by adding thereto the following proviso: *Provided*, That such deed, or the record thereof, shall be evidence in like manner and with the same force and effect as the certificate provided for in section eighty-four (84) of this chapter.

SEC. 2. This act shall take effect and be in force from and after its passage, but shall not apply to or affect any deed the validity of which is involved in any action now

pending in any court of this state.

CHAPTER 16.

AN ACT TO AMEND SECTION ONE HUNDRED AND SEVENTYTWO (172) OF CHAPTER EIGHT (8) OF THE GENERAL STATUTES OF ONE THOUSAND EIGHT HUNDRED AND SEVENTYEIGHT (1878), RELATING TO SALARIES OF COUNTY TREASURERS.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That section one hundred and seventy-two (172) of chapter eight (8) of the general statutes of one thousand eight hundred and seventy-eight (1878) be and is hereby amended by adding thereto the following words: Provided further, That whenever the salary of the county treasurer is limited to a fixed sum by the second provise of this section, said fixed sum shall be paid in the manner provided above, at the end of each month, in twelve equal

Whenever salary is limited, how paid. installments, and no treasurer receiving pay for his services under said second proviso, whose salary cannot be certainly and exactly fixed at the beginning of his official year, shall receive more than one-twelfth of his annual salary at the end of each month as carefully estimated and recorded by the board of county commissioners at their January meeting in each year, and the balance of the year's pay found to be legally due the treasurer shall be paid him on the computation of said board of commissioners at their next January meeting.

CHAPTER 17.

AN ACT TO AMEND SECTION THREE (3), TITLE THREE (3), CHAPTER SEVEN (7), GENERAL STATUTES OF ONE THOU-SAND EIGHT HUNDRED AND SEVENTY-EIGHT (1878), RELAT-ING TO SALARIES OF COUNTY ATTORNEYS.

Be it enacted by the Ligislature of the State of Minnesota:

SECTION 1. That section three (3) of title three (3) of Increase or chapter seven (7), general statutes of one thousand eight hundred and seventy-eight (1878), be, and the same is hereby amended by striking out the words "twelve hundred" in the second line of said section three (3) and insert in lieu thereof the words "two thousand."
