

## CHAPTER 211.

AN ACT TO REPEAL CHAPTER ONE HUNDRED AND FORTY-ONE (141) OF THE GENERAL LAWS OF ONE THOUSAND EIGHT HUNDRED AND EIGHTY-THREE (1883), AND AMEND SECTION EIGHTY-EIGHT (88) OF CHAPTER THIRTY-TWO (32), TITLE EIGHT (8), GENERAL STATUTES RELATING TO THE SNAKE RIVER SLUICE DAM IN PINE COUNTY.

*Be it enacted by the Legislature of the State of Minnesota:*

Fixing the  
amount of toll.

SECTION 1. That section eighty-eight (88) of chapter thirty-two (32), title eight (8) of the general statutes relating to sluice dams be and the same is hereby amended by adding thereto the following proviso: *Provided*, That at the Snake river dam in Pine county, the said toll may be ten (10) cents.

Repeal of  
former act.

SEC. 2. That chapter one hundred and forty-one (141) of the general laws of one thousand eight hundred and eighty-three (1883), relating to said subject, be and the same is hereby repealed.

When act to  
take effect.

SEC. 3. This act shall take effect and be in force from and after its passage.

## CHAPTER 212.

AN ACT TO REGULATE THE AMOUNT OF TOLL THAT MAY BE TAKEN BY ANY CUSTOM MILL IN THIS STATE, FOR THE GRINDING AND BOLTING OF WHEAT OR OTHER GRAIN, THAT MAY BE BROUGHT TO SUCH MILL FOR THAT PURPOSE.

*Be it enacted by the Legislature of the State of Minnesota:*

Fixing rate of  
toll.

SECTION 1. That it shall be unlawful for any custom mill doing business in this state to take a larger proportion than one-eighth ( $\frac{1}{8}$ ) as toll for grinding and bolting any lot of wheat or other grain brought as a grist to such mill; *Provided*, That nothing in this act shall be construed to compel mills to receive unmerchantable grain or to flour the same.

SEC. 2. That for the willful violation of the terms of this act by any miller, in any custom mill in this state it shall be the duty of any justice of the peace, within the county in which such mill is situated, upon complaint of the aggrieved party, to issue his warrant directed against such offending person, and upon the conviction of such person, he shall be fined not less than ten (10) dollars nor more than one hundred (100) dollars.

Penalty for violation.

SEC. 3. This act shall take effect and be in force from and after its passage.

When act to take effect.

## CHAPTER 213.

AN ACT TO PREVENT THE KILLING OF DUCK, GEESE; SWAN OR ANY OTHER FOWL AT NIGHT, BY THE USE OF ARTIFICIAL LIGHT, ON ANY OF THE LAKES, RIVERS, STREAMS OR MARSHES IN THIS STATE.

*Be it enacted by the Legislature of the State of Minnesota :*

SECTION 1. It shall be unlawful for any person or persons to kill or pursue with intent to kill any duck, geese, swan or any other fowl at night by the use of artificial light, on any of the lakes, rivers, streams or marshes in this state.

Unlawful to kill by the use of artificial light.

SEC. 2. Any person or persons violating any of the provisions of the preceding section shall be guilty of a misdemeanor, and upon conviction thereof shall suffer and pay a fine of not less than five (5) dollars nor more than twenty-five (25) dollars, together with costs of prosecution.

Penalty for violation.

SEC. 3. All prosecutions under the provisions of this act shall be commenced by complaints under oath within thirty (30) days from the time the offense was committed, before any justice of the peace in said county, and all fines collected under the provisions of this act shall be paid into the common school fund of the county.

How actions to be brought.

SEC. 4. This act shall take effect and be in force from and after its passage.

When act to take effect.
