## CHAPTER 279.

AN ACT TO APPROPRIATE MONEY TO MEET EXPENSES OF THE STATE BOARD OF HEALTH ARISING FROM ANY EMERGENCY THAT MAY ARISE FROM CHOLERA IN THE STATE.

*Be it enacted by the Legislature of the State of Minnesota :*

In case of  
cholera, expense  
how paid.

SECTION 1. That the sum of fifteen thousand dollars (\$15,000), or so much thereof as may be necessary, be and the same is hereby appropriated out of any money in the treasury not otherwise appropriated, for the purpose of meeting and paying the expense which may be incurred by the state board of health in any emergency that may arise from cholera in this state.

SEC. 2. That said money shall be expended under the direction of the governor, and shall be paid out on the warrant of the state auditor. Vouchers for such expenditures giving the details thereof approved by the governor, shall be filed with the state auditor.

## CHAPTER 280.

AN ACT TO APPROPRIATE MONEY FOR DEFRAYING THE EXPENSES OF STATE INSTITUTES.

*Be it enacted by the Legislature of the State of Minnesota :*

SECTION 1. That the sum of one thousand dollars (\$1,000), in addition to the sum now allowed by law, be

appropriated for the year one thousand eight hundred and eighty-five (1885), and annually thereafter, out of any moneys not otherwise appropriated, for defraying the current expenses of state institutes under the direction of the superintendent of public instruction.

SEC. 2. This act shall take effect and be in force from and after its passage.

## CHAPTER 281.

AN ACT TO APPROPRIATE MONEY TO PAY FOR THE SERVICES AND EXPENSES OF THE LUNACY COMMISSION.

*Be it enacted by the Legislature of the State of Minnesota:*

SECTION 1. There is hereby appropriated out of any money in the treasury not otherwise appropriated, the sum of six hundred dollars, for the years one thousand eight hundred and eighty-four (1884) and one thousand eight hundred and eighty-five (1885), and three hundred dollars annually thereafter, to pay the services and expenses of the lunacy commission.

SEC. 2. This act shall take effect and be in force from and after its passage.

## CHAPTER 282.

AN ACT TO APPROPRIATE MONEY TO ARCHIBALD McELRATH FOR INTEREST PAID ON UNIVERSITY LAND.
