

## CHAPTER 44.

AN ACT TO AMEND SECTION SIX (6) OF CHAPTER ONE HUNDRED AND FORTY-TWO (142) OF THE GENERAL LAWS OF ONE THOUSAND EIGHT HUNDRED AND EIGHTY-THREE (1883), ENTITLED AN ACT TO REORGANIZE THE STATE AGRICULTURAL SOCIETY, AND TO APPROPRIATE MONEY THERETO AND TO OTHER AGRICULTURAL SOCIETIES.

*Be it enacted by the Legislature of the State of Minnesota :*

SECTION 1. That section six (6) of chapter one hundred and forty-two (142) of the general laws of one thousand eight hundred and eighty-three (1883), is hereby amended by adding after the words "fairs" in the fourth (4th) line and "Minnesota butter, cheese, dairy and stock association."

## CHAPTER 45.

AN ACT TO AMEND SECTION TWELVE (12) OF CHAPTER EIGHTY-THREE (83) OF THE GENERAL LAWS OF ONE THOUSAND EIGHT HUNDRED AND SEVENTY-FIVE (1875), RELATING TO TOWN INSURANCE COMPANIES.

*Be it enacted by the Legislature of the State of Minnesota :*

SECTION 1. Section twelve (12) of chapter eighty-three (83) of the general laws of one thousand eight hundred and seventy-five (1875) be amended so as to read as follows:

Sec. 12. It shall be the duty of the secretary of every company as aforesaid, to prepare a statement showing the condition of such company on the day preceding their annual meeting, which statement shall contain the amount insured, the number of policies issued, and such other matters pertaining to the interest of the company as may be deemed important, which statement shall be filed in the office of the town clerk of the town in which said company may be located, on or before the fifteenth (15th) day of Jan-

uary in each year, and which statement shall also be read to the members of said company at their annual meeting.

## CHAPTER 46.

AN ACT TO AMEND CHAPTER FORTY-THREE (43) OF THE GENERAL LAWS OF THE STATE OF MINNESOTA FOR THE YEAR ONE THOUSAND EIGHT HUNDRED AND EIGHTY-THREE (1883), RELATING TO THE HUSBAND'S AGENCY IN THE CASE OF MECHANICS' LIENS.

*Be it enacted by the Legislature of the State of Minnesota:*
