# CHAPTER 71.

### AN ACT TO AMEND CHAPTER ONE HUNDRED AND EIGHT (108) OF GENERAL LAWS OF ONE THOUSAND EIGHT HUN-DRED AND EIGHTY-THREE (1883), RELATING TO THE DRAINAGE OF LANDS.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That chapter one hundred and eight (108) Strike out and of the general laws of one thousand eight hundred and eighty-three (1883) be and the same hereby is amended by striking out the words "regular session," wherever they occur in said chapter and inserting in lieu thereof the word "session," and by striking out the words "regular meeting" wherever they occur in said chapter, and inserting in lieu thereof the word "meeting."

SEC. 2. That section thirty-three (33) of said chapter Strike out. be and the same hereby is amended by striking out the first (1st) five (5) lines of said section and the first (1st) word of the sixth (6th) line thereof.

## CHAPTER 72.

## AN ACT TO AMEND SECTION SIXTY-THREE (63) OF TITLE ONE (1) OF CHAPTER THIRTY-FOUR (34) OF THE GENERAL STATUTES OF ONE THOUSAND EIGHT HUNDRED AND SEV-ENTY-EIGHT (1878), RELATING TO CORPORATIONS.

#### Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That section sixty-three (63) of chapter thirtyfour (34) of the general statutes of one thousand eight hundred and seventy-eight (1878) be and the same hereby is amended by inserting before the word "corporation," in the first (1st) line of said section, the word "other;" and also by inserting after the word "road," in the third (3d) line of said section, the following: "to wit, for the passage of vessels or articles of commerce through their canals, locks or other
