

CHAPTER 87.

AN ACT TO AMEND SECTION ONE HUNDRED AND TWO (102) OF CHAPTER EIGHT (8) OF THE GENERAL STATUTES OF ONE THOUSAND EIGHT HUNDRED AND SEVENTY-EIGHT (1878), RELATING TO THE MEETINGS OF COUNTY COMMISSIONERS IN OTTER TAIL COUNTY.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That section one hundred and two (102) of chapter eight (8) of the general statutes of one thousand eight hundred and seventy-eight (1878) be amended by adding to the end thereof the following proviso, viz.: *Provided*, That the limitation prescribed in this section relative to the length of regular and extra sessions, shall not apply to the county commissioners of Otter Tail county.

Not applicable to county commissioners.

SEC. 2. All acts and parts of acts inconsistent with this act are hereby repealed.

Repeal of inconsistent acts.

SEC. 3. This act shall take effect and be in force from and after its passage.

When act to take effect.

CHAPTER 88.

AN ACT TO AMEND SECTION ONE (1) OF CHAPTER TWENTY-EIGHT (28) OF THE GENERAL LAWS OF THE EXTRA SESSION OF THE YEAR ONE THOUSAND EIGHT HUNDRED AND EIGHTY-ONE (1881), RELATING TO THE COUNTY COMMISSIONERS OF OTTER TAIL COUNTY.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That section one (1) of chapter twenty-eight (28) of the general laws of the extra session of the year one thousand eight hundred and eighty-one (1881) be amended by adding to the end thereof the following provision, viz.: *And provided further*, That the provisions of this act, so far as the same limits the number of days in each year that such commissioners shall draw pay, or fixes the number of sessions for attendance upon which such commissioners

Not applicable to certain commissioners.

Limit to per diem.

shall be entitled to mileage, shall not apply to the commissioners of Otter Tail county; *Provided further*, That the number of days for which said commissioners shall draw pay shall not exceed fifty (50) days in one year.

Repeal of inconsistent acts.

SEC. 2. All acts and parts of acts inconsistent with this act are hereby repealed.

When act to take effect.

SEC. 3. This act shall take effect and be in force from and after its passage.

CHAPTER 89.

AN ACT TO AMEND SECTION TWO (2) OF CHAPTER SIXTY-EIGHT (68) OF THE GENERAL LAWS OF THE YEAR ONE THOUSAND EIGHT HUNDRED AND EIGHTY-ONE (1881), RELATING TO CLERK HIRE IN THE OFFICE OF THE COUNTY TREASURER OF OTTER TAIL COUNTY.

Be it enacted by the Legislature of the State of Minnesota:

SECTION. 1. That section two (2) of chapter sixty-eight (68) of the general laws of one thousand eight hundred and eighty-one (1881) be amended so as to read as follows:

Clerk hire, amount allowed.

Sec. 2. That section one hundred and seventy-two (172) of said chapter eight (8) be amended by adding to the end thereof the following proviso, viz.: *Provided*, That the county, commissioners of Otter Tail county may in their discretion allow the county treasurer of said Otter Tail county such sum as they shall deem just, not to exceed in any one year the sum of twelve hundred (1,200) dollars for clerk hire in the treasurer's office, and for clerk hire and expenses in visiting towns in said county to collect personal property tax.

When act to take effect.

SEC. 2. This act shall take effect and be in force from and after its passage.
