said bonds and the interest thereon, until all of said bonds and coupons shall be fully paid; which payment shall be made by the treasurer of said county upon the presentation to him of any of said bonds or coupons which are due and unpaid.

SEC. 6. This act shall take effect and be in force from and after its

passage.

CHAPTER 180.

AN ACT TO AUTHORIZE THE COUNTY OF DAKOTA, STATE OF MINNESOTA, TO LEVY A TAX UPON THE REAL ESTATE IN THE TOWNSHIPS OF BURNSVILLE, EGAN AND MENDOTA, FOR THE PURPOSE OF GRADING AND BRIDGING THE "ST. PAUL AND SHAKOPEE WAGON ROAD," FROM THE VILLAGE OF MENDOTA TO THE CITY LIMITS OF ST. PAUL, MINNESOTA.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That the county auditor of the county of Dakota, state of Minnesota, is hereby authorized and required to place and extend the sum of two thousand (2,000) dollars upon the tax rolls of said county for the year one thousand eight hundred and eighty-five (1885) against all of the real estate liable to taxation lying and situated within the limits of the township of Burnsville, and within the limits of road districts numbered one (1) and two (2) in the township of Mendota, and within the limits of road districts numbered three (3) and four (4) in the township of Egan, all situated in the county of Dakota, state of Minnesota, in the following proportions, viz.: One thousand (1,000) dollars shall be levied upon all the real estate in the township of Burnsville. One hundred (100) dollars shall be levied upon all the real estate in road district numbered one (1) in the township of Mendota. Four hundred (400) dollars shall be levied upon all the real estate in road district numbered two (2) in the township of Mendota. Two hundred (200) dollars shall be levied upon all the real estate in the road district numbered three (3) in the township of Egan; and three hundred (300) dollars shall be levied upon all the real estate in road district numbered four (4) in the township of Egan, for the purpose of aiding in the grading and bridging of the "Saint Paul and Shakopee wagon road," from the village of Mendota, Dakota county, to the city limits of the city of Saint Paul, Ramsey county, on the line of the said road as it is at present surveyed, or

may be hereafter surveyed and located by the proper authority now

provided by law.

SEC. 2. Said tax shall be placed and extended by the said county auditor upon the tax rolls of the said county of Dakota, for the year one thousand eight hundred and eighty-five (1885), as above provided, unless the board of county commissioners of the said county shall determine to levy the said tax in three (3) annual installments, commencing with the year one thousand eight hundred and eighty-five

(1885), being a privilege hereby granted to said board.

SEC. 3. The taxes authorized to be levied by this act shall be collected and paid as other taxes are collected and paid in said county of Dakota, and as soon as the said taxes are collected and paid to the county treasurer of said Dakota county it shall be the duty of the county auditor of said Dakota county to draw and issue a warrant upon the county treasury of said Dakota county for the amount so collected, in favor of the city treasurer of the city of Saint Paul, Ramsey county, state of Minnesota, and upon the delivery of same shall take the receipt of the said city treasurer, but said warrant shall not be delivered until the said city treasurer furnishes a certificate of the city clerk of the city of Saint Paul that a contract or contracts to the amount of six thousand (6,000) dollars have been made and entered into by the city of Saint Paul, and duly countersigned by the city comptroller of said city for the improvement as contemplated by this act; but, before the city of Saint Paul shall make or enter into any contracts for said improvement, the county of Dakota must furnish the said city of Saint Paul with the free right of way through the land necessary to be taken for the im-Also, it shall be the duty of the county auditor of said provement. Dakota county to notify the city treasurer of said city of Saint Paul that the warrant for the settlement of the taxes authorized to be levied by this act is ready for delivery to him, upon his furnishing the city clerk's certificate, as required by this act then said contracts can be made.

SEC. 4. This act shall take effect and be in full force from and after its passage.
