CHAPTER 184.

AN ACT TO AUTHORIZE THE CLERK OF THE DISTRICT COURT OF THE COUNTY OF CROW WING TO TRANSCRIBE CERTAIN RECORDS IN HIS OFFICE.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. That the clerk of the district court for the county of Crow Wing, in this state, is hereby authorized, at the expense of said Crow Wing county, to procure suitable books, the forms thereof to be approved by the judge of the district court, for the transcribing of the docket entries of all judgments docketed in said court. now remaining in full force and unsatisfied, and in which said clerk shall enter all judgments not heretofore docketed, and which are now in full force and unsatisfied. And the said clerk shall, before the first (1st) day of September, in the year of our Lord one thousand eight hundred and eighty-five (1885), transcribe such judgment docket entries into the books or book so procured as aforesaid, and when so transcribed, such transcribed record shall have the same force and effect in all respects, whether as evidence or otherwise, as the original record thereof.

SEC. 2. That said clerk shall, at the expense of said Crow Wing county, procure suitable books, the forms thereof to be approved by the judge of said court, for the purpose of transcribing the indexes of actions and proceedings, and of the records of naturalization and marriage records in said clerk's office, to record all marriage certificates in said office which have not heretofore been recorded, and to index such other records as the judge of said court may direct. And the said clerk shall, as soon as practicable, transcribe such indexes into

such books so procured as aforesaid.

SEC. 3. That as compensation for the services to be rendered as provided for in sections one (1) and two (2) the said clerk shall receive from said Crow Wing county as follows: For transcribing entries in the judgment docket, for each judgment debtor, fifteen (15) cents; for transcribing indexes to actions and proceedings, for each name, five (5) cents; for compiling and transcribing indexes to naturalization records, for each name, five (5) cents; for compiling and transcribing indexes to marriage records, for each name, five (5) cents; for indexing all other records which may be ordered by the judge of said court, for each name indexed, five (5) cents; and for all other services under this act, the same fees as are allowed by law for like services.

SEC. 4. Said compensation shall be paid by the county commissioners of said county, on the certificate of the court that the work has been properly done, and all judgments thereafter docketed and all

actions thereafter commenced in said court, shall be entered in said system of dockets and indexes so adopted as provided in sections one (1) and two (2) of this act; and the said dockets and indexes shall be official records of said clerk's office, and of like force and effect as similar records hitherto kept in said office.

SEC. 5. This act shall take effect and be in force from and after

its passage.

CHAPTER 185.

AN ACT TO AUTHORIZE THE RED WING AND TRENTON TRANSIT COM-PANY TO ESTABLISH AND MAINTAIN A FERRY ACROSS THE MISSIS-SIPPI RIVER, AT THE CITY OF RED WING, IN THE COUNTY OF GOOD-HUE.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That the Red Wing and Trenton Transit company, and its successors and assigns, shall have the exclusive right and privilege, for the period of ten (10) years, of keeping and maintaining a ferry across the main channel of the Mississippi river, at the city of Red Wing, in the county of Goodhue, in this state, at any point within one mile eastwardly or westwardly, up and down the said river, from the foot of Broad street in said city where the same strikes said river.

SEC. 2. That the said Red Wing and Trenton Transit company, and its successors and assigns, shall, in each and every year, at the opening of uninterrupted navigation in said main channel, cause to be placed and maintained upon such ferry, such good and sufficient boat or boats as may be necessary for the accommodation of foot passengers, and to transport across said main channel all teams, horses, cattle, and other animals and property, desiring to be, or offered for transportation across said channel, and shall, at all times between five (5) o'clock in the forenoon and eight (8) o'clock in the afternoon of each and every day during the season of the navigation of said channel, give ready and prompt attention to the passing and repassing of passengers, teams and animals by means of said ferry across said channel.

SEC. 3. That it shall be lawful for the said Red Wing and Trenton Transit company, its successors and assigns, to land their boats, and passengers, animals, and other property transported thereon, on any
