CHAPTER 208.

AN ACT TO DETACH CERTAIN TERRITORY FROM CARMAN (COMMON) SCHOOL DISTRICT IN POLK COUNTY, IN THE STATE OF MINNESOTA, AND ATTACH THE SAME TO SCHOOL DISTRICT NUMBER FIFTY-FIVE (55) IN SAID COUNTY.

Be it enacted by the Legislature of the State of Minnesota :

SECTION 1. That the east one-half $(\frac{1}{2})$ of sections five (5), eight (8) and seventeen (17), in township one hundred and forty-nine (149) north, of range forty-six (46), and lots seven (7), eight (8), nine (9) and twelve (12) in section thirty-two (32), township one hundred and fifty (150) north, of range forty-six (46) west, in the county of Polk, now attached to and forming a part of Carman (common) school district of said Polk county, be and the same is hereby detached from the said Carman (common) school district, and is hereby attached to common school district number fifty-five (55), in said Polk county.

SEC. 2. This act shall take effect and be in force from and after its passage.

CHAPTER 209.

AN ACT TO DETACH CERTAIN TERRITORY FROM CARMEN SPECIAL SCHOOL DISTRICT AND ATTACH THE SAME TO INDEPENDENT SCHOOL DISTRICT NUMBER ONE (1), IN POLK COUNTY, MINNESOTA.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That lots two (2), seven (7), eight (8), nine (9), eleven (11), twelve (12), fifteen (15), sixteen (16), and the northwest quarter ($\frac{1}{4}$) of the southeast quarter ($\frac{1}{4}$) and the south half ($\frac{1}{2}$) of the southeast quarter ($\frac{1}{4}$) of section numbered thirty-one (31), and lots [numbered] five (5), eight (8), nine (9), and the south half ($\frac{1}{2}$) of the southwest

quarter ($\frac{1}{2}$) of section numbered thirty-two (32), all in township one hundred and fifty (150) north of range numbered forty-six (46), in the county of Polk, be, and the same is hereby, detached from Carmen special school district and attached to independent school district number one (1), of said county of Polk.

SEC. 2. This act shall take effect and be in force from and after its passage.

CHAPTER 210.

AN ACT TO DETACH CERTAIN TERRITORY FROM SCHOOL DISTRICT NUMBER NINETY-TWO (92), IN THE COUNTY OF LE SUEUR, AND AT-TACH THE SAME TO SCHOOL DISTRICT NUMBER FIFTY-FOUR (54), IN THE SAME COUNTY.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That the east half $(\frac{1}{2})$ of the southwest quarter $(\frac{1}{4})$, less two (2) acres, and lots respectively numbered one (1) and two (2), in section fifteen (15), town one hundred and eleven (111), range twenty-three (23), at present constituting a part of school district number ninety-two (92), in the county of Le Sueur, be, and same is hereby, detached from said school district number ninety-two (92), and attached to and made a part of school district number fifty-four (54), in said county.

SEC. 2. This act shall take effect and be in force from and after its passage.
