## CHAPTER 258.

AN ACT TO REGULATE THE TERMS OF OFFICE OF THE COUNTY COM-MISSIONERS OF STEARNS COUNTY.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That the terms of the offices of the county commissioners of Stearns county shall be as follows: The commissioners of the first (1st), fourth (4th) and fifth (5th) districts shall hold their respective offices until the first (1st) day of January, A. D. one thousand eight hundred and eighty-seven (1887), and until their successors are elected and qualified; the commissioners of the second (2d) and third (3d) districts shall hold their offices until the first (1st) day of January, A. D. one thousand eight hundred and eighty-nine (1889), and until their successors are elected and qualified. And hereafter when any commissioner is elected for said county he shall be elected for four (4) years.

SEC. 2. This act shall take effect and be in force from and after its

passage.

## CHAPTER 259.

AN ACT TO REGULATE THE CATCHING OF FISH IN OSAKIS LAKE, SIT-UATE IN DOUGLAS AND TODD COUNTIES, AND TO PREVENT SHIP-MENT OF FISH CAUGHT IN SAID LAKE.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That it shall be unlawful for any person or persons to take, catch or kill any kind of fish in lake Osakis, situate in the counties of Douglas and Todd, or in any waters running into said Osakis lake, from the fifteenth (15th) day of Maych to the fifteenth (15th) day of May in any year.

of May in any year.

SEC. 2. That no person shall export or ship from the railroad depot at Osakis, in said Douglas county, fish of any kind taken from the

waters of said Osakis lake or the waters running into said lake.

- SEC. 3. Any person or persons violating the provisions of this act, upon conviction thereof, shall pay a fine for such and every such offense, of not less than five (5) dollars nor more than twenty-five (25) dollars.
- SEC. 4. This act shall take effect and be in force from and after its passage.

## CHAPTER 260.

AN ACT TO PROHIBIT THE CATCHING OR DESTRUCTION OF FISH IN WAVERLY OR LITTLE WAVERLY LAKES, IN THE TOWNSHIP OF MARYSVILLE, OR BUFFALO OR PULASKI LAKES, IN THE TOWNSHIP OF BUFFALO, WRIGHT COUNTY, MINNESOTA, BETWEEN THE DATES OF DECEMBER FIRST (1st) AND THE FOLLOWING FIRST (1st) DAY OF MAY IN EACH YEAR.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That it shall be unlawful for any person or persons to catch, kill, or destroy any fish within the waters of Waverly or Little Waverly lakes in the township of Marysville, or Buffalo or Pulaski lakes, in the township of Buffalo, Wright county, Minnesota, or in any outlet or inlet of said lakes within one (1) mile thereof, between the first (1st) day of December and the following first (1st) day of May

in each year.

SEC. 2. Whoever violates the provisions of the preceding section shall be deemed guilty of a misdemeanor, and upon conviction thereof shall be punished by a fine of not less than five (5) nor more than ten (10) dollars for each and every offense, together with the costs of prosecution, and in default of the payment thereof shall be committed to the county jail for a term not exceeding thirty (30) days. Justices of the peace shall have jurisdiction of all prosecutions under this act, and all fines arising from such prosecutions shall be paid into the county treasury of Wright county for the use of the common schools of said county.

SEC. 3. This act shall take effect and be in force from and after its

passage.
